

#### Introduction

Bridgewater is believed to be a locational name, derived from the town of Bridgewater in Somerset, England, but I have found no connection between "our" Bridgewaters and the town in Somerset.


This document is focussed on my wife's Bridgewater ancestors who lived in the parish of West Wycombe, Buckinghamshire, England in the 1700s, and is intended to provide a general overview of the many descendant branches of our Bridgewater family tree. There will be more information on my wife's immediate family, and their story, as that is what I am most familiar with, but I hope that it will also provide a better understanding of the other descendant lines, and how we are all related.

Throughout the document, to protect their privacy, I have tried to avoid providing details of living relatives, and I apologise if this cut-off has not been perfectly executed.

This is not intended to be the final word on the Bridgewater family of West Wycombe, and I hope that over time, new information will be identified, and that people from the various descendant branches might add additional chapters to this document, expanding the story of their Bridgewater lines.

I apologise for any errors that may have crept into the document, and I welcome any corrections, family photographs, or other feedback, which can be incorporated into future versions.

The chart on the next page shows with yellow highlight, the ancestral line that is the focus of this document.



#### **Chapter 1 – The Early Generations**

Our earliest confirmed Bridgewater ancestor is William Bridgewater, born circa 1791 at West Wycombe. His 1845 marriage certificate states that his father was William Bridgewater, a chairmaker, but he was not baptised in either West Wycombe or High Wycombe.

A search of neighbouring parishes identifies two possibilities in Hughendon parish, which borders West Wycombe –

- William Bridgewater, son of William Bridgewater and Elizabeth Fox, baptised 27 November 1791.
- William Bridgewater, son of William Bridgewater and Mary Maye, who were married in Hughendon on 26 October 1788.

William Bridgewater senior was buried in West Wycombe on 17 July 1838, at the age of 73 years, suggesting that he was born circa 1765. The local newspaper<sup>i</sup> reported his death as follows – "SUDDEN DEATH – William Bridgewater, a chair-maker, was found dead in his workshop with a chisel in his hand; he is advanced in years".

Bridgewater is not a common surname in the area, and the only identified William Bridgewater born circa 1765 is the baptism of William Bridgewater, son of George and Mary Bridgewater, in High Wycombe on 21 February 1768.

George Bridgewater baptised four children in High Wycombe, as follows -

- Martha Bridgewater, baptised 17 May 1761
- Richard Bridgewater, baptised 26 December 1762
- William Bridgewater, baptised 21 February 1768
- Henry Bridgewater, baptised 17 February 1769

The High Wycombe parish registers also identify a marriage of George Bridgewater and Mary Costard on 3 February 1768. The register states that George Bridgewater was a widower at the time of the marriage, suggesting that the first two of the children listed above may have a different mother than the last two children, but also named Mary. This would also explain the five year gap between the baptism of Richard and William.


The only identified candidate as the mother of Martha and Richard is Mary Collingwood, who married George Bridgewater on 6 November 1760 in West Wycombe, and presumably died between 1762 and 1768, although no burial record has been found.

Mary Bridgewater, the mother of William and Henry, is likely the Mary Bridgewater buried in High Wycombe on 7 April 1820, aged 73 years. This suggests a birth date circa 1747.


The connection to William Bridgewater, born circa 1791, is only an educated guess at this time, but in the absence of evidence to the contrary, the foregoing will be accepted as the most likely familial relationships.

The Martha Bridgewater baptised on 17 May 1761 married John Dean in High Wycombe on 9 April 1781. No further research has been done to date on this line nor on Richard and Henry Bridgewater.

William Bridgewater, born circa 1791 will be covered in more detail in chapter 2.



#### **Chapter 2 – William Bridgewater and Elizabeth (Collins?)**




William Bridgewater first appeared in the census records of West Wycombe in 1841<sup>ii</sup>, living at Plomer Hill with four children (Catherine, Mary Ann, Elizabeth and William). He is listed as a 45 year old farmer, but ages of adults were rounded down to the nearest five years, suggesting that he was born between 1791 and 1796.

In the 1851 census<sup>iii</sup>, 58 year old William is listed with wife Mary, two children (William and Elizabeth) and grandson Arthur Bridgewater. The family was still living at Plomer Hill, and William was farming 90 acres and employing five men.

From these two census records, it appears that William was a widower in 1841 and married Mary between 1841 and 1851. This scenario is confirmed by a newspaper notice<sup>iv</sup> announcing the marriage of William Bridgewater and Mary Stratton in Princes Risborough on 13 December 1845.

# MARRIED. On Saturday last, at Princes Risborough Church, by the Rev. C. Gray, by licence, Mr. William Bridgewater, chairmanufacturer and farmer, Downly, West Wycombe, Bucks, to Miss Mary Stratton, daughter of the late Mr. John Young Stratton, Princes Risborough.

But who was William Bridgewater's first wife?

The West Wycombe parish registers identify the baptism of eight children of William and Elizabeth Bridgewater, as follows –

- Ellinor Bridgewater, baptised 27 October 1818
- Ellen Bridgewater, baptised 27 May 1821
- Catherine Bridgewater, baptised 7 July 1822
- Catherine Bridgewater, baptised 20 July 1823
- Mary Ann Bridgewater, baptised 29 May 1825
- Elizabeth Jane Bridgewater, baptised 20 March 1826
- Sophia Bridgewater, baptised 16 August 1829
- William James Bridgewater, baptised 30 March 1833

Elizabeth, the mother of these eight children, was buried in West Wycombe on 19 September 1834, aged 42 years, so she was born circa 1792. The only likely marriage that I have found in the area, for a William Bridgewater to an Elizabeth, between 1808 and 1818, is the marriage of William Bridgewater and Elizabeth Collins in nearby Little Missenden on 7 December 1816. I am confident that Elizabeth Collins is the mother of the eight Bridgewater children, but I do not have proof, so I will add her surname in brackets, with a question mark, to the family charts in this document. We will talk more about DNA in chapter 11, but I will say at this point that there is some DNA evidence that this Collins connection is likely correct.

William Bridgewater did not live for very long with his second wife, as he died in West Wycombe on 13 December 1852. His will leaves bequests to his wife Mary, son William James, daughter Mary Ann Spriggs wife of Charles Spriggs, daughter Catharine wife of Henry Fox, children of his late daughter Ellen who was the wife of Frederick Herbert Tilbury, and daughter Elizabeth Jane.

William Bridgewater was not a poor man when he died. He did not own Plomer Hill Farm, but leased it from the local landowner. In addition to the farm, William also held 11 cottages in the village of Downley, by copyhold. His executors posted notices in the local newspapers, announcing the sale by auction of William Bridgewater's property, including the copyhold cottages<sup>v</sup> and his farming equipment & household effects<sup>vi</sup>. The auction notice for his farming equipment and household effects, listed the following items for sale –

"THE LIVE AND DEAD FARMING STOCK comprises three Cart Horses, a Pony, two in-calf Cows and 2 Sturks, Rick of Wheat, three iron-arm market waggons, timber-carriage and chains, three dung -carts, market cart, ploughs and tackle, harrows, winnowing -machine, rick-stands, gig, cart and plough harness, Barn Implements, and effects. The useful HOUSEHOLD FURNITURE consists of mahogany four-post, tent, and other bedsteads, with furniture; goosefeather beds, hair and wool mattresses, and bedding; mahogany chests of drawers; dining and other tables; chairs; carpets; glassed bookcase; bureau; two pianofortes; china and glass; kitchen utensils and fixtures".

After the death of William, his wife Mary disappears from the West Wycombe records, but I believe that she is the Mary Bridgewater who married George Stratton in Wycombe Registration District in the Oct-Dec quarter of 1853.

Ellinor Bridgewater, the eldest daughter, is not mentioned in her father's will and was not living with him in 1841 or 1851, so is assumed to have died prior to his death.

Ellen Bridgewater married Frederick Herbert Tilbury and their family will be covered in chapter 3.

The elder Catherine Bridgewater is assumed to have died as baby, as the next child, born a year later, was also named Catherine.


The younger Catherine Bridgewater married Henry William Fox and their family will be covered in chapter 4.

Mary Ann Bridgewater married Charles Spriggs and their family will be covered in chapter 5.


Elizabeth Jane Bridgewater did not marry and died in West Wycombe on 5 October 1872 at the age of 46 years.

Sophia Bridgewater was buried on 18 October 1829 at the age of two months.

William James Bridgewater married Susanna Bristow and their family will be covered in chapter 6.



#### Chapter 3 – Ellen Bridgewater and Frederick Tilbury



Ellen Bridgewater was baptised at West Wycombe, Buckinghamshire, on 27 May 1821, the second child of James and Elizabeth Bridgewater.

On 4 August 1840 she married Frederick Herbert Tilbury at West Wycombe, and the marriage produced five children.


Ellen died at the age of 29 years and was buried in West Wycombe cemetery on 11 January 1851. Her husband lived on for many years, and died in the Jul-Sep quarter of 1900.

The known descendants of Ellen Bridgewater and Frederick Tilbury are as follows -



#### **Chapter 4 – Catherine Bridgewater and Henry Fox**



Catherine, the fourth child of William and Elizabeth Bridgewater was baptised at West Wycombe on 20 July 1823.

She married Henry William Fox on 19 February 1849 at St. Luke, Chelsea, Middlesex, and their marriage produced eleven children.


Catherine died at West Wycombe on 11 April 1873 at the relatively young age of 49 years. Her husband, Henry Fox, died at West Wycombe on 2 August 1896.



#### Chapter 5 – Mary Ann Bridgewater and Charles Spriggs



Mary Ann, the fifth child of William Bridgewater and Elizabeth (Collins?) married Charles Spriggs, son of Thomas Spriggs and Elizabeth Saunders, in West Wycombe parish church on 20 September 1849. In the 1851 census<sup>vii</sup>, they were found living at Gurdens Farm in Stokenchurch, Oxfordshire, with a daughter, Eliza. Charles Spriggs was farming 117 acres and employing 3 agricultural labourers and a general servant, so he was doing well for himself.

When Mary Ann's father, William Bridgewater, died in December 1852, it seems that she and Charles Spriggs moved onto his property, Plomer Green Farm, almost immediately, as their fourth child, William, was born in West Wycombe in early 1854.

By 1861 they had produced a total of eight children, but sadly only six were still living at the time of the 1861 census<sup>viii</sup>. Eliza had died in 1855 at five years of age, and George, born in 1858 had died in 1859, before he was nine months old. Four year old daughter, Amy, was not listed with the family in the census, and does not appear to have been enumerated elsewhere.

Charles and Mary Ann Spriggs produced a total of 11 children, of whom 9 lived to adulthood, 8 married and 7 had children of their own. By 1881 the family had moved from Plomer Green Farm to the nearby Plomer Hill Farm, where they remained until Charles' death in 1887. Mary Ann continued living on the farm, with her eldest son, Charles, until her death in 1900.

Charles Spriggs was obviously well respected in the community, as documented in his obituary from the Bucks Free Press newspaper -


Death of Mr. C. Spriggs - This parish has this week sustained a severe loss by the removal by death of Mr. Charles Spriggs, of Plomer Hill, which took place at his residence on Monday morning, after a short illness. The cause of death was bronchitis; the deceased was out as lately as Tuesday week. The deceased was Chairman of the School Board, one of the vicepresidents of the Horticultural Society, and surveyor, and has at various times held almost every public office in parochial matters with credit to himself and to the satisfaction of the parish generally. He was a most zealous and painstaking officer in all the duties he undertook, and will be greatly missed at the School Board, and also at the Horticultural Society's meetings, in the welfare of which he took an especial interest, particularly the Poultry Show in connection with the above, in the formation of which he was one of the most active promoters. The deceased had for some years been a member of the Board of Guardians, and only retired from the office a few weeks ago. He was an excellent Guardian, and rendered useful and intelligent service during his occupation of the post. He was closely connected with the Wesleyan body at Downley, in fact, in every useful society or movement affecting the parish generally. He was always ready to assist, and from his large experience and sound judgement his advice was always acceptable. We may say of him that he was a good citizen and a kind neighbour. The funeral is arranged to take place on Friday (to-day) at West Wycombe Church at 5 o'clock, the procession starting from deceased's residence at four.

Charles and Mary Ann Spriggs are buried in the churchyard of St. Lawrence's church in West Wycombe, Buckinghamshire, beneath a prominent headstone.

- West Wycombe.






With such a large family it is easy to lose track of the various descendant lines, so we will cover William and Selby in this chapter, as they had no known descendants, then Thomas (Marlene's great grandfather) in chapter 7 and the remaining children in chapter 8.


William, born in 1854, was the fourth child of Charles and Mary Ann Spriggs, and took up the trade of chair-making, which was a major industry in the West Wycombe area in the latter half of the 19<sup>th</sup> century. In the 1891 census he is still living at Plomer Hill Farm, where he is described as single, 36 years old, a farmer's son. I have lost track of him after 1891, as he does not

appear in either the 1891 or 1901 census of West Wycombe, so do not know whether or not he married and had a family. Perhaps he emigrated?

Selby Spriggs was the 8<sup>th</sup> child of Charles and Mary Ann and was born in 1860. He became a grocer, and continued living at Plomer Hill Farm until his marriage to Emily Sarah Heybourne in 1896. After their marriage, Selby and Emily opened their own grocer's shop in the village of Downley, where they lived until Selby's death in 1919 at 59 years old. Selby and Emily did not have children. Emily continued to run the grocery store until her death in 1945. They too are buried in the West Wycombe churchyard.



#### Chapter 6 – William James Bridgewater and Susanna Bristow



William James Bridgewater was the youngest child and only son of William and Elizabeth Bridgewater. He was baptised at West Wycombe on 30 March 1833.

On 4 December 1854 he married a local girl, Susanna Bristow at West Wycombe. The couple had a daughter, Elizabeth, born in the Apr-Jun quarter of 1856, but who died just two years later, while Susanna was pregnant with their second child, William Arthur Bridgewater.

Sadly, William James Bridgewater did not get to see his son, as he died in West Wycombe at 25 years old, on 27 August 1858, just a few weeks before William Arthur's birth in mid-September.

Susanna married Thomas Nash on 5 June 1870, and had one additional child, Thomas Walter Nash. Thomas Nash died in early 1871, around the time his son was born, leaving Susanna a widow again, at 37 years of age. Susanna did not remarry and died on 5 January 1909, more than 50 years after the death of her first husband.


As a young man, William Arthur Bridgewater left England for Australia, and on 20 December 1881 he married Amy Blanche Coe in Collingwood, Victoria, under the name of William Arthur Bridgewater Lacey. It is unclear why William changed his surname, but as he was the only male line descendant of William and Elizabeth Bridgewater, and his descendants bear the surname Lacey, the Bridgewater surname disappeared from our family tree, but was used as a second given name in some lines of the family.



#### **Chapter 7 - Thomas Spriggs and Sarah Annie Barton**



Thomas Spriggs, the fifth child and third son of Mary Ann Bridgewater and Charles Spriggs, was born in West Wycombe, Buckinghamshire, in 1855. By 1871<sup>ix</sup> he was apprenticed to Frederick Manning, a local draper, and was living at 4 Oxford Street in High Wycombe. A butcher, Charles Barton, was living next door at 2 Oxford Street, with his family. In the style of the time, the families lived above their shop.

In 1875, at 20 years old, Thomas married Sarah Annie Barton, eldest daughter of the butcher, Charles Barton, and they moved to Newlands in High Wycombe. Charles Barton was likely not very happy about his daughter marrying the draper's apprentice, but Sarah was 7 months pregnant, so this was a better option than Sarah giving birth as a single woman.

By 1881<sup>x</sup>, Thomas and Sarah were living at Water Street, with Thomas working as a grocer, and employing an apprentice of his own. The census identifies 3 children, but Sarah had borne two other children who died as babies – the first born, Annie, in 1876, and Thomas, born in 1879 who died at less than 6 months old in 1880. The grocery business must have been doing well, as the family could afford a house servant, Lizzie Jones.

In 1891<sup>xi</sup> the family was living at Brook Street, with Sarah taking care of the grocery business and Thomas working as a provision traveller. Perhaps the family needed the additional income as three more children had joined the family – Eva, Alice and Henry H. (known as Hamp). Sadly, two other children born to the family since the last census did not see their first birthday – Charles born in 1886 and Edith born in 1887 had died in 1886 and 1888 respectively. There was one other child born to Thomas and Sarah between 1881 and 1891, who was not listed with the family in the 1891 census – Stanley, born in 1882, was found in the household of his mother's sisters at Bridgers Yard, off Easton Street.

The family was still living in Brook Street in 1901<sup>xii</sup>, with one new addition to the family – Arthur D. Spriggs. The family had again lost two young children – Edward, born in 1892, had died in 1896 and Gertrude, born in 1896 died as an infant.

Several of the older children, Bertha, Ethel and Alfred, had left home by this time. At the time of the census, Bertha was living on London Road with her Mother's sister Ada, and working as a dressmaker. Ethel and Alfred had moved to London, where Ethel worked as a boot saleswoman and Alfred, a butcher by trade, had joined the army and was fighting in the South Africa (Boer) war.

The 1911 census<sup>xiii</sup> identified that Thomas was now a widower, with Sarah having died on 20 November 1910 at the age of 55 years. Bertha Nellie and Arthur Douglass were living at home, along with Marjorie Reid, daughter of Eva Spriggs. Eva was heavily pregnant with her second child at the time, so had perhaps sent Marjorie to stay with the grandfather and aunt.




Thomas Spriggs & family in 1911 census.

Thomas and Sarah had produced a total of 14 children, 8 of whom lived to adulthood, 6 married, and 5 produced children of their own. Thomas survived the second world war, and died in early 1947, aged 91 years.

Ethel Spriggs did not marry, continued working as a saleswoman, and died in High Wycombe on 1 February 1972.

Alice Spriggs married a storekeeper, Ernest Hancock, in High Wycombe in 1930. The couple had no children, and Ernest died in 1969. Alice died in Northampton on 7 November 1982.

Henry Hamp Spriggs, known as Hamp, emigrated to Duck Lake, Saskatchewan, Canada, as did his brothers Alfred and Arthur. Hamp took out a homestead on the block next to his brother Alfred, but sold it in 1912 and moved into the village of Duck Lake. He died on 29 April 1913 after falling through the ice on a local river.




Thomas Spriggs (1855 - 1947).



#### **Chapter 8 - Other Children of Mary Bridgewater & Charles Spriggs**



We will look briefly at the other children of Charles Spriggs and Mary Ann Bridgewater.

Mary Spriggs married a Scottish gas engineer, Peter Buchen Watson, in London in 1870. They had nine children, the first six of whom were born in High Wycombe and the remaining three were born in Scotland. Several of the children later returned to live in England.

Charles Spriggs, being the eldest son, remained on the farm at Plomer Hill, and married Ellen Field in 1894. Charles died in 1928 and Ellen in 1931. Charles and Ellen had two sons, John Powesland Spriggs and Charles Powesland Spriggs, born in 1895 and 1896 respectively. I have no idea where the Powesland name came from, as it does not appear as a surname in either family back several generations.

John P. Spriggs remained in West Wycombe and married Bessie Harvey in 1931. John and Bessie did not have any children together, but John fathered a child (Susan Margaret Catling) with a widow named Winifred Catling, in Princes Risborough in 1952. John P. Spriggs died in West Wycombe in 1958, and Bessie died in Dorset in 1975.

Susan was adopted by John and Joan Orton, was raised as Susan Jane Orton and is now known by her married name, Jane Roach. She lives in West Sussex.

Charles P. Spriggs married Fanny Townsend, daughter of a local vicar, but this marriage ended in divorce in 1936. Charles P. Spriggs then married Doris Palmer in 1937. Their marriage produced two children – Gillian Rose in 1940 and Charles Andrew in 1947. Charles, Doris and family lived at Benson, Oxfordshire, and later at the New Inn, Blewbury, Berkshire. After Charles P. Spriggs' death in 1954,

Doris and her daughter Gillian emigrated to New Zealand, where Doris died in 1985 and is buried in the Anglican churchyard in Keri Keri. Jane and Gillian were unaware of each other's existence until DNA testing revealed the genetic connection between them early in 2020.

Amy Spriggs married William Henry Collins in London in 1876 and had seven children, who were all born in the Wycombe area. William Collins died in 1924 and Amy died in Brentford, Middlesex in 1946.

Hamp Spriggs married Helen Hill in London in 1888 and had two children, Edith and Wilfred, who were both born in Kingston Blount, Oxfordshire. Hamp was a grocer, draper and subpostmaster in Kingston Blount, and died 24 October 1939, just two and a half months after Helen's death.

Bridgewater Spriggs married Florence Hall in 1895, and they had four sons – Stewart, Arnold, Norman and Cyril. Bridgewater ran a furniture manufacturing / upholstery business in Wycombe, and died in 1951, four years after Florence's death. Stewart died in Palestine during World War I. Arnold died as a baby and Cyril died in a motorcycle accident in 1928. Norman married and had a daughter named Barbara.



Lizzy Spriggs (1869– 1959).

Lizzy Spriggs married Charles Henry Cherry in London in 1892. Soon after their marriage Charles and Lizzy emigrated to the United States of America. Their two children, Gertrude and Linden were born in Chicago, Illinois in 1893 and 1896 respectively. The family moved to Benton Harbor, Michigan, where Charles died in 1941. Lizzy then moved to California and died in Los Angeles in 1959. Lizzy and Charles have descendants still living in California.

Below I have provided the basic details that I have on the descendants of Charles Spriggs and Mary Ann Bridgewater, but I have limited the details to four generations in an effort to avoid detailing living people –



#### Chapter 9 - Arthur Douglass Spriggs and Elsie Elizabeth Preston



Arthur Douglass Spriggs was born in High Wycombe, Buckinghamshire, England on 23 March 1893, the last child of Thomas and Sarah Spriggs to reach adulthood. His younger sister Gertrude had died as a baby.

In 1911 Arthur left High Wycombe and headed to Saskatchewan, Canada, to join his brothers Alfred and Henry (Hamp) in Duck Lake. In 1912 he applied for a homestead on the front of the SW quarter of Section 33, Township 45, Range 6, West of the 3<sup>rd</sup> meridian. He worked his property in the summer months and helped his brother Alfred in his butchery business in the winter.

The First World War broke out in 1914, and on 8 June 1915 Arthur signed up to serve in the Canadian Overseas Expeditionary Force, attesting at Saskatoon, Saskatchewan. The then 22 year old butcher is recorded on the attestation papers as being 5 ft. 7 ½ in. tall, with fair hair and blue eyes. After agreeing to the nature and terms of engagement, agreeing to be vaccinated, and passing the medical inspection he was deemed fit for service.

Arthur did not immediately go overseas, as on 6 November 1915 he married Florence Edna Reid in All Saints Anglican church in Duck Lake. But just two weeks later, on 23 November 1915 he sailed for England with the 5<sup>th</sup> Canadian Mounted Rifles, and by January of 1916 he had joined the fighting in mainland Europe.

The war was not kind to Arthur, but he did survive it. On 31 May 1916 he was hospitalized due to trench fever while serving at Ypres in Belgium, returning to the trenches on 22 July. The battalion moved to France, and in September he was promoted to Lance Corporal, whilst serving at the Somme. In October, still fighting at the Somme, an exploding shell buried him in a dugout from which he suffered a contusion of the back and shell shock, which took him out of the fight. Arthur spent six months in hospital in England, and on leaving hospital he returned, at his own request, to the ranks. He served in England for the remainder of the war and returned to Canada in May 1919, after 3 ½ years away, to find his wife and her 6 month old daughter living with another man.

On leaving the army, Arthur moved to Saskatoon and joined the Canadian Post Office as a mail clerk, a position he held until his retirement in 1958. Arthur settled into life in Saskatoon, joined the choir at the local Anglican church, and it was here that he met Elsie Elizabeth Preston. Elsie was also born in England, and had come to Canada with her parents and her brother Ted in 1908.

Arthur Spriggs and Elsie Preston were married on 14 September 1929 at the Knox United church in Saskatoon, Saskatchewan. On the marriage registration, both listed their religion as Anglican, so we can only guess that the Anglican minister perhaps would not marry a divorced person, even one who sang in his choir, hence their marriage in the United church. After their wedding, Arthur and Elsie lived at 914 – 5<sup>th</sup> Avenue North, just down the street from Elsie's parents, who lived at number 901. Here they raised two children, Gerald, born in 1931 and his younger sister, Gladys. During the summer months the family would spend time at Waskesiu Lake in Prince Albert National Park, along with the family of Arthur's brother, Alfred.

In the late 1970s Arthur and Elsie moved from their home of 30 years into an apartment just a few blocks away. It was here that Arthur died in 1981 and Elsie in 1998. Both are buried in the Woodlawn cemetery in Saskatoon.

Gerry joined the Royal Bank of Canada in Saskatoon at 18 years old and continued working in the bank until his retirement in 1987, never staying in one city for more than a few years at a time. He was working in Rosetown, Saskatchewan when he met Fredda Sim, and they married in Rosetown in 1953, as Gerry was being transferred to Foam Lake, Saskatchewan. They moved to Foam Lake the following week, and it was there that their daughter Marlene Lynn (my wife), and son, Arthur William, were born, before Gerry was transferred to Regina (1957), Montreal (1965), Calgary (1966), Montreal (1969), Toronto (1976) and Winnipeg (1982). Their third child, Robert Gerald, was born in Montreal. After retirement, Gerry and Fredda relocated to Cloverdale, British Columbia, to enjoy the coastal climate. But Gerry's golden years were cut

short and he died in 1989 at his daughter's house in Calgary, and he is buried there in the Queen's Park cemetery.




Gerry Spriggs & Fredda Sim's wedding.



Gladys Spriggs Nursing Graduation.


Gladys graduated as a nurse and spent her career working in hospitals and care facilities. She married Mervyn Smith in Saskatoon in 1959, which is where they raised their two sons, and where Mervyn died in 1991 after a career in the City of Saskatoon Electrical Department.



To respect the privacy of the living family members, this is where I will end the story of the Spriggs family's 200+ year journey from Toot Baldon, Oxfordshire, through Buckinghamshire and on to Canada, leaving the next generation to continue the story at some point in the future.

All that remains is to provide brief details of the lives of the other children of Thomas Spriggs and Sarah Annie Barton.

#### Chapter 10 – Other children of Thomas Spriggs & Sarah A. Barton



Bertha Nellie Spriggs was born in High Wycombe in 1917 and married James Lunn, a soldier, in 1917. They do not appear to have had any children. At some point Bertha travelled to South Africa, as while travelling from Cape Town to Liverpool on the M.V. Ambosso, she died on 29 October 1942 when the ship was torpedoed by German submarine U-575, 589 nautical miles north of the Azores.

Alfred Spriggs, the eldest son to survive to adulthood, was born in 1881. He served with British forces in the South African (Boer) War, before emigrating to Duck Lake, Saskatchewan, Canada. In 1905 he married Laura Kennedy and they produced 9 children. Alfred and Laura have numerous living descendants, many of whom are still in Saskatchewan. Alfred operated a butchery business, a skill that he no doubt learned from his maternal grandfather, Charles Barton, back in High Wycombe. He died in 1962 and Laura died in 1973. Both are buried in the Duck Lake cemetery.

Stanley George Spriggs was born 21 April 1882. He worked as an upholsterer and married Rose Gomme in 1905. Stanley and Rose raised 4 children, with their second son, Ronald Stanley, dying in an automobile accident in 1937. The remaining 3 children all married and had children of their own.

Eva Spriggs was born in 1884 and worked as a boot shop assistant, before marrying Robert Reid in Falkirk, Scotland in 1908. Eva and Bob Reid raised 4 children in Scotland, and Eva died there in 1971.


#### Chapter 11 – DNA Testing

The foregoing chapters have identified many of the descendants of William Bridgewater, born circa 1791 in West Wycombe, Buckinghamshire, based primarily on public records. So it would be nice to be able to confirm the validity of the ancestral lines as researched.

Autosomal DNA testing, through companies such as Ancestry, 23andMe, MyHeritage and FamilyTreeDNA, is of huge benefit to genealogists in confirming familial connections identified by researching the paper trail of our ancestors. If two people who have well-researched family trees, which identify a common ancestor, also share autosomal DNA, and if there is no other obvious ancestral connection, then it is highly likely that the identified common ancestor is correct.

Through comparison of the autosomal DNA results of my wife, Marlene Spriggs, with the results of others who have taken DNA tests (DNA matches), I have found several Bridgewater cousins who were previously unknown to me, including descendants of three of the four children of William Bridgewater and Elizabeth (Collins?) who are known to have children. So autosomal DNA testing has been instrumental in confirming my wife's Bridgewater ancestry. Identification of shared DNA between Marlene Spriggs and Bridgewater line relatives at the second, third and fourth cousin levels reinforces the accuracy of the researched line back to William Bridgewater and Elizabeth (Collins?).

The chart below shows several of Marlene's Bridgewater connections confirmed with autosomal DNA testing, but not all known DNA connections have been included in the chart to improve readability.

As mentioned in chapter 2, Marlene has one DNA match who shares DNA with several of the people in the chart above, but does not have Bridgewater ancestry. He is however descended from a Collins line from the West Wycombe area, reinforcing the likelihood of William Bridgewater's (b. 1791) wife being Elizabeth Collins. But further research is required to confirm or refute this theory.

There are many other people who have taken autosomal DNA tests, with whom Marlene shares significant amounts of DNA, and with whom it appears that she may share a common Bridgewater ancestor, but unfortunately there is no paper trail to establish the correct relationship.

It is unlikely that relatives beyond fifth cousins will share significant amounts of autosomal DNA, so for more distant connections on the male ancestral line, Y-DNA testing can also be very useful.

The Y-chromosome is passed down the male line from father to son, largely unchanged, although mutations do occur from time to time. It is these mutations that create what is termed "genetic distance" between Y-DNA samples – the genetic distance between two samples increases by 1 with each mutation on either line of descent from a common ancestor. The relative stability of the Y-chromosome is therefore useful in identifying common male ancestors in ancient times.

The only known male line descendants of William Bridgewater (1791-1852), are the Lacey line from Australia. If any male Lacey line descendants living today were to take a Y-DNA test, it could be useful in learning more about the earlier Bridgewater ancestry. These tests are frequently on sale from FamilyTreeDNA, especially around Black Friday in November.
