

Chapter 1 – The Beginning

No clear origin for the surname Spriggs has been found, but it is generally believed to have originated as Sprig, meaning tall, thin and bony. The surname Sprag is found in Suffolk, England in the 1300s and Spriggs is found in York and London in the late 1600s and early 1700s. It is also considered by some to be a derivative of the surname Sprague, but my research has made no connection between my wife's (Marlene) Spriggs family and the surname Sprague or other variants. In the 1881 census of England, the surname Spriggs was most prolific in Northamptonshire.

'Our' Spriggs have been traced back to the parish of Toot Baldon and the neighbouring parish of Marsh Baldon, about 6 miles south east of the City of Oxford, England, in the mid-1700s. The Baldons were fair-sized villages, each with a population of around 200 people in 1800, and were largely self-supporting.

One of the first Spriggs entries in the parish registers of St. Lawrence's church in Toot Baldon, Oxfordshire, is the baptism on 2 January 1757, of James Spriggs, the son of Mary Spriggs.


No father is mentioned in the baptism record, suggesting that James may possibly have been illegitimate. However, several Spriggs men in the Toot Baldon area in the 1700s married women named Mary (see the Addendum for unconnected Spriggs families), so it is equally possible that Mary, the mother of James, may have been the wife of one of these men.

No other children of Mary Spriggs have been found in baptism records in the area, and no marriage of Mary Spriggs has been identified, but she is likely the Mary Spriggs who was buried in Toot Baldon on 6 September 1795. No age is given on the burial entry, making it very difficult to determine when and where Mary might have been born. This is the research brick wall that has prevented the identification of earlier Spriggs generations.

Mary Spriggs and her son James were not the only Spriggs living in the Toot Baldon area in the mid-1700s, but I have not been able to connect Mary to any of these other Spriggs families, which include a Richard Spriggs, son of Richard and Mary Spriggs, baptised in 1748 in Toot Baldon, and an Abraham Spriggs who married Mary Hayward in nearby Marcham, Berkshire, in 1766. These currently unconnected families have been added as an addendum at the end of this document.



Chapter 2 – DNA Testing

Autosomal DNA testing, through companies such as Ancestry, 23andMe, My Heritage and FamilyTreeDNA, is of huge benefit to genealogists in confirming connections identified by researching the paper trail of our ancestors. If two people who have well-researched family trees, which identify a common ancestor, also share autosomal DNA, and if there is no other obvious ancestral connection, then it is highly likely that the identified common ancestor is correct. I have found many previously unknown Spriggs cousins through autosomal DNA testing, back to half 5th cousins, so it is a very powerful tool. But the more distant the relationship, the lower will be the amount of DNA shared by two people, such that beyond about 5th cousins it ceases to be very useful.


The Mary Spriggs identified in chapter 1 as our earliest known Spriggs ancestor, is eight generations back from my wife's generation (Marlene Lynn Spriggs), meaning that descendants of any other children of Mary, who are in the same generation, would be my wife's 6th cousins, and descendants of Mary's siblings, would be 7th cousins. At the 7th cousin level, two people, on average will share only 14 centiMorgans (cM) (0.02% of their DNA), and there is a 97% probability that they will share no measurable amount of autosomal DNA, so autosomal DNA is unlikely to help in confirming Spriggs ancestry beyond Mary.

Under most circumstances, we could turn to Y-DNA to trace the Spriggs male line, beyond the 6th cousin level, but if James Spriggs (born 1782) was illegitimate, as his baptism record (naming no father) might suggest, then tracing the male line back from the present would not be tracing the Spriggs surname beyond James. Regardless, it would be interesting to learn how James Spriggs fits into the overall male haplotree of human kind, and it could help us learn more about the Spriggs ancestral line.


I therefore encourage male Spriggs descendants to take the Big Y-700 test at FamilyTreeDNA, or even the somewhat cheaper Y-111 test, which could help to clarify whether James Spriggs shares Y-DNA with other unconnected Spriggs males, or might at least point to a surname for his father, if he was illegitimate. These tests are frequently on sale, especially around Black Friday in November. To date I am not aware of any Toot Baldon Spriggs male descendants who have taken Y-DNA tests, so even one person testing would be useful, and several, from different lines of descent would be a bonus.

At this point we will acknowledge the limitation of DNA testing to date, accept the brick wall on the paper trail, and focus on documenting Mary's known descendants.

Chapter 3 – James Spriggs and Elizabeth Woodbridge



James Spriggs, son of Mary, married Elizabeth Woodbridge in Toot Baldon on 11 December 1782, one of only two marriage ceremonies performed in the parish in 1782.

This marriage produced 4 children, who were all baptised in the Toot Baldon parish church, as follows –

Ann Spriggs, baptised 11 June 1786

Thomas Spriggs, baptised 18 May 1790

Joseph Spriggs, baptised 30 December 1792

Richard Spriggs, baptised 9 August 1795

Joseph and Richard died within a week of one another, in September 1799, likely succumbing to one of the numerous childhood diseases of the period.



There is no further record of Ann in the Toot Baldon or Marsh Baldon parish registers, suggesting that she may have married in another parish. One possibility, recently discovered through autosomal DNA testing, is that she is the Ann Spriggs who married Charles Rose in Thame, Oxfordshire in 1810. This is certainly a strong possibility, as at least two descendants of Ann and Charles Rose share autosomal DNA with descendants of Ann's brother, Thomas Spriggs, and this will be explored further in chapter 6.

Thomas Spriggs left Toot Baldon as a young man, and next appears in Tetsworth, Oxfordshire, where he married Elizabeth Saunders on 22 October 1816. We will explore Thomas' life in

chapter 5, but first we need to examine the life of James Spriggs, his father, a little further, in chapter 4.




Chapter 4 – James Spriggs and Ann Dawson

The Toot Baldon parish registers identify the marriage of a James Spriggs and an Ann Dawson on 8 May 1815. This James Spriggs is not found in the 1841 census, but his widow Ann is found living at Toot Baldon, with her son John, John's wife Harriett and their daughter Jane.


Ann Spriggs & family in 1841 census.

This identifies that Ann was born about 1786, and if we assume that James was a few years older than Ann, he would have been born about 1784, which would suggest that he is possibly the eldest child of James Spriggs and Elizabeth Woodbridge, born between their marriage in 1782 and the birth of their daughter Ann in 1786. It was not unusual for women to return to their mother's home for the birth of their first child, so he could have been baptised in another parish. However no baptism has been found for a James Spriggs in this time period in Toot Baldon or any of the surrounding parishes.

Elizabeth Spriggs (nee Woodbridge), wife of the James Spriggs born in 1757, died in 1814 and was buried on 8 September 1814 in Toot Baldon churchyard, so it is also possible that the year after Elizabeth died, the widower James Spriggs married the much younger Ann Dawson.







There is shared autosomal DNA between several descendants of Elizabeth Woodbridge and several descendants of Ann Dawson, so we know that there is a biological connection between the son of Elizabeth Woodbridge (Thomas Spriggs) and the son of Ann Dawson (John Spriggs), but we cannot tell if John Spriggs was Thomas' half-brother or if he was his nephew.

Unless other evidence comes to light refuting this, as there was only a burial record for one James Spriggs in Toot Baldon / Marsh Baldon in the relevant time period, I will assume that there was one James Spriggs with two wives – Elizabeth Woodbridge and Ann Dawson.

James Spriggs died in 1822, and his wife Ann died in 1854, leaving only one child, John, who was baptised in Toot Baldon on 26 May 1816. The Spriggs surname was therefore only passed on through two children of James Spriggs, one from each wife.



Chapter 5 – Thomas Spriggs and Elizabeth Saunders



Thomas Spriggs was baptised 18 May 1790, the second child and eldest son of James Spriggs and Elizabeth Woodbridge. He next appears in Tetsworth, Oxfordshire, where he married Elizabeth Saunders on 22 October 1816.

The Tetsworth parish registers identify three children born of the marriage of Thomas Spriggs and Elizabeth Woodbridge -

- George Spriggs, baptised 30 January 1820
- Charles Spriggs, baptised 13 January 1822
- Mary Spriggs, baptised 13 January 1825

By 1841, the family had moved to Moreton, Oxfordshire, with Thomas, Elizabeth, Charles and Mary found together in the census, but no sign of George. Thomas, the son of an agricultural labourer, was doing well for himself, as he was now listed as a farmer, employing two farm servants. Perhaps he married well? Ages in this census were rounded down to the nearest 5 years, hence both children are listed as being 15 years old.

In the 1851 census, the family was living at Little Kimble, Buckinghamshire, but Charles appears to have left home. Thomas is now a farmer of 30 acres, employing one labourer. George and Mary are both still single, and no doubt working on the farm.

Tragedy struck in December 1852, when George died, still single at the age of 32 years. His burial entry in the Little Kimble parish register provides no information on what may have been the cause of his death.

Two years later, on September 7th, 1854, Mary married Henry Hamp, a 22-year-old draper, in the London parish of Stepney. The following year Henry and Mary welcomed a son, whom they named Thomas, but unfortunately Thomas died as an infant, and Henry and Mary had no other children. They are found in the 1861 and later censuses, operating a grocer and draper's business in the village of Kingston Blount, which is situated in the parish of Aston Rowant, Oxfordshire. Henry and Mary adopted and raised Margaret Clubb Watson, the eldest child of Mary's niece, Mary Spriggs and Peter Buchan Watson. Henry and Mary Hamp remained in Kingston Blount until their deaths in 1893 and 1919 respectively.


With George dead and Charles moved away, Thomas Spriggs retired from farming, and he and Elizabeth relocated to Kingston Blount, no doubt to be close to their daughter, Mary. Thomas died there in 1867 and Elizabeth nine years later in 1876. Thomas' probate entry, in the National Probate Index, identifies him as a gentleman, and also indicates that his son Charles is living at Downley in the parish of West Wycombe, Buckinghamshire.



Chapter 6 – Ann Spriggs and Charles Rose



Until recently I had found no record of a marriage or burial in the Toot Baldon area of Ann Spriggs, the eldest child of James Spriggs and Elizabeth Woodbridge, but that changed in late 2020 with new DNA evidence.

Ancestry.com identified Marie Pennykid of Australia as a DNA match to Marlene, and based on Marie's online tree, suggested that Marie is descended from Ann Spriggs, a daughter of James Spriggs and Elizabeth Woodbridge. Marlene and Marie only share 9 cM of DNA, but this is not surprising, given that they would be fifth cousins once removed. 8 cM is the minimum amount of shared DNA that Ancestry considers for DNA matching, as very small amounts of shared DNA can be identical by chance, rather than by descent, so it is possible that this is not a real DNA match. But two of Marlene's Spriggs cousins, Jane Roach and Gillian Spriggs, share 9 cM and 8 cM respectively with Marie, making this connection more likely. With assistance from Marie I was able to find another DNA match, Jan Brooks, who shares DNA with Marie and with Gillian. The chart below shows the relationships and amount of DNA shared by the five testers -

This is not conclusive evidence that the Ann Spriggs in Marie and Jan's ancestry is the same Ann Spriggs who was baptised in Toot Baldon in 1786, but it strongly suggests that this is the case.

Is it realistic that Ann would have travelled the 9 miles from Toot Baldon to Thame, Oxfordshire to marry Charles Rose in the early 1800s? We know that Ann's brother, Thomas, moved 8 miles from Toot Baldon, to live at Tetsworth, Oxfordshire, and later moved to Little Kimble, Buckinghamshire, which is 8 miles on the other side of Thame, so it seems quite plausible to me.

Unfortunately, the 1810 church marriage entry for Ann Spriggs and Charles Rose in the Thame, Oxfordshire parish records identifies Ann as being "of this parish", rather than identifying a connection to Toot Baldon. So this does not provide positive confirmation on Ann's birth place, merely that she was resident in Thame at the time of her marriage.

Given the strong DNA evidence, and with no evidence to the contrary, I am assuming that the Ann Spriggs who married Charles Rose in Thame, Oxfordshire in 1810, was the daughter of James Spriggs and Elizabeth Woodbridge, born in Toot Baldon in 1786.





Chapter 7 – John Spriggs and Harriett Claydon



In chapter 4 we identified that James Spriggs and Ann Dawson had only one child – John Spriggs, who was baptised in Toot Baldon on 26 May 1816. John married Harriet Claydon in 1840 and produced nine children over the following 25 years. They lived their entire lives in Toot Baldon, and died there in 1885 and 1883 respectively.



As this is not my wife's ancestral line, I have not researched all of these descendant lines in great detail, but have extracted information from sources readily available online to provide some detail on the descendants of John Spriggs and Harriett Claydon. What is apparent is that Edwin, their youngest child, was the only son who produced children, again limiting the spread of the Spriggs surname.



Chapter 8 – Charles Spriggs and Mary Ann Bridgewater



Charles Spriggs, son of Thomas Spriggs and Elizabeth Saunders, was not living with his parents in the 1851 census, but he was found living at Gurdens Farm in Stokenchurch, Oxfordshire, with a wife, Mary A., and daughter, Eliza. Charles was farming 117 acres and employing 3 agricultural labourers and a general servant, so he was doing well for himself.

In 1849 Charles had married Mary Ann Bridgewater, daughter of West Wycombe farmer, William Bridgewater. Just three years later, William Bridgewater died in December 1852, and it seems that Charles and Mary Ann moved onto his property, Plomer Green Farm, almost immediately, as their fourth child, William, was born in West Wycombe in early 1854.

By 1861 they had produced a total of eight children, but sadly only six were still living at the time of the 1861 census. Eliza had died in 1855 at five years of age, and George, born in 1858 had died in 1859, before he was nine months old. Four-year-old daughter, Amy, was not listed with the family in the census, and does not appear to have been enumerated elsewhere.

Charles and Mary Ann Spriggs produced a total of 11 children, of whom 9 lived to adulthood, 8 married and 7 had children of their own. By 1881 the family had moved from Plomer Green Farm to the nearby Plomer Hill Farm, where they remained until Charles' death in 1887. Mary Ann continued living on the farm, with her eldest son, Charles, until her death in 1900.

Charles Spriggs was obviously well respected in the community, as documented in his obituary from the Bucks Free Press newspaper -

Death of Mr. C. Spriggs - This parish has this week sustained a severe loss by the removal by death of Mr. Charles Spriggs, of Plomer Hill, which took place at his residence on Monday morning, after a short illness. The cause of death was bronchitis; the deceased was out as lately as Tuesday week. The deceased was Chairman of the School Board, one of the vice-presidents of the Horticultural Society, and surveyor, and has at various times held almost every public office in parochial matters with credit to himself and to the satisfaction of the parish generally. He was a most zealous and painstaking officer in all the duties he undertook, and will be greatly missed at the School Board, and also at the Horticultural Society's meetings, in the welfare of which he took an especial interest, particularly the Poultry Show in connection with the above, in the formation of which he was one of the most active promoters. The deceased had for some years been a member of the Board of Guardians, and only retired from the office a few weeks ago. He was an excellent Guardian, and rendered useful and intelligent service during his occupation of the post. He was closely connected with the Wesleyan body at Downley, in fact, in every useful society or movement affecting the parish generally. He was always ready to assist, and from his large experience and sound judgement his advice was always acceptable. We may say of him that he was a good citizen and a kind neighbour. The funeral is arranged to take place on Friday (to-day) at West Wycombe Church at 5 o'clock, the procession starting from deceased's residence at four.

Charles and Mary Ann Spriggs are buried in the churchyard of St. Lawrence's church in West Wycombe, Buckinghamshire, beneath a prominent headstone.



Charles & Mary Ann Spriggs headstone – West Wycombe.



With such a large family it is easy to lose track of the various descendant lines, so we will cover William and Selby in this chapter, as they had no known descendants, then Thomas (Marlene's great grandfather) in chapter 9 and the remaining children in chapter 10.


William, born in 1854, was the fourth child of Charles and Mary Ann Spriggs, and took up the trade of chair-making, which was a major industry in the West Wycombe area in the latter half of the 19th century. In the 1891 census he is still living at Plomer Hill Farm, where he is described

as single, 36 years old, a farmer's son. Around the time of his mother's death in 1900, William moved north to Falkirk in Scotland, perhaps to be near his elder sister, Mary, who had moved there in the early 1880s with her husband and family. On 30 November 1900 William married Mary Ann Cruickshank in Falkirk, but the marriage produced no children. William Spriggs died in Falkirk on 18 December 1920 and his wife, Mary Ann, died in nearby Larbert in 1960 at the age of 95 years.

Selby Spriggs was the eighth child of Charles and Mary Ann and was born in 1860. He became a grocer and continued living at Plomer Hill Farm until his marriage to Emily Sarah Heybourne in 1896. After their marriage, Selby and Emily opened their own grocer's shop in the village of Downley, where they lived until Selby's death in 1919 at 59 years old. Selby and Emily did not have children. Emily continued to run the grocery store until her death in 1945. They too are buried in the West Wycombe churchyard.



Chapter 9 - Thomas Spriggs and Sarah Annie Barton



Thomas Spriggs, the fifth child and third son of Charles Spriggs and Mary Ann Bridgewater, was born in West Wycombe, Buckinghamshire, in 1855. By 1871 he was apprenticed to Frederick Manning, a local draper, and was living at 4 Oxford Street in High Wycombe. A butcher, Charles Barton, was living next door at 2 Oxford Street, with his family. In the style of the time, the families lived above their shop.

In 1875, at 20 years old, Thomas married Sarah Annie Barton, eldest daughter of the butcher, Charles Barton, and they moved to Newlands in High Wycombe. Charles Barton was likely not very happy about his daughter marrying the draper's apprentice, but Sarah was 7 months pregnant, so this was a better option than Sarah giving birth as a single woman.

By 1881, Thomas and Sarah were living at Water Street, with Thomas working as a grocer, and employing an apprentice of his own. The census identifies 3 children, but Sarah had borne two other children who died as babies – the first born, Annie, in 1876, and Thomas, born in 1879 who died at less than 6 months old in 1880. The grocery business must have been doing well, as the family could afford a house servant, Lizzie Jones.

In 1891 the family was living at Brook Street, with Sarah taking care of the grocery business and Thomas working as a provision traveller. Perhaps the family needed the additional income as three more children had joined the family – Eva, Alice and Henry H. (known as Hamp). Sadly, two other children born to the family since the last census did not see their first birthday – Charles born in 1886 and Edith born in 1887 had died in 1886 and 1888 respectively. There was one other child born to Thomas and Sarah between 1881 and 1891, who was not listed with the family in the 1891 census – Stanley, born in 1882, was found in the household of his mother's sisters at Bridgers Yard, off Easton Street.

The family was still living in Brook Street in 1901, with one new addition to the family – Arthur D. Spriggs. The family had again lost two young children – Edward, born in 1892, had died in 1896 and Gertrude, born in 1896 died as an infant.

Several of the older children, Bertha, Ethel and Alfred, had left home by this time. At the time of the census, Bertha was living on London Road with her mother's sister Ada, and working as a dressmaker. Ethel and Alfred had moved to London, where Ethel worked as a boot saleswoman and Alfred, a butcher by trade, had joined the army and was fighting in the South Africa (Boer) war.

The 1911 census identified that Thomas was now a widower, with Sarah having died on 20 November 1910 at the age of 55 years. Bertha Nellie and Arthur Douglass were living at home, along with Marjorie Reid, daughter of Eva Spriggs. Eva was heavily pregnant with her second child at the time, so had perhaps sent Marjorie to stay with the grandfather and aunt.




Thomas Spriggs & family in 1911 census.

Thomas and Sarah had produced a total of 14 children, 8 of whom lived to adulthood, 6 married, and 5 produced children of their own. Thomas survived the second world war, and died in early 1947, aged 91 years.

Ethel Spriggs did not marry, continued working as a saleswoman, and died in High Wycombe on 1 February 1972.

Alice Spriggs married a storekeeper, Ernest Hancock, in High Wycombe in 1930. The couple had no children, and Ernest died in 1969. Alice died in Northampton on 7 November 1982.

Henry Hamp Spriggs, known as Hamp, emigrated to Duck Lake, Saskatchewan, Canada, as did his brothers Alfred and Arthur. Hamp took out a homestead on the block next to his brother Alfred, but sold it in 1912 and moved into the village of Duck Lake. He died on 29 April 1913 after falling through the ice on a local river.




Thomas Spriggs (1855 – 1947).




Sarah Annie Barton (1855 – 1910).

Chapter 10 - The Other Children of Charles and Mary Ann Spriggs



We will look briefly at the other children of Charles Spriggs and Mary Ann Bridgewater.

Mary Spriggs married a Scottish gas engineer, Peter Buchan Watson, in London in 1870. They had fourteen children, the first six of whom were born in High Wycombe and the remaining eight were born in Falkirk, Scotland. The eldest child, Margaret Clubb Watson, did not travel to Scotland and was raised in Aston Rowant, Oxfordshire by her mother's aunt, Mary Spriggs and her husband Henry Hamp. Several of the older children later returned to live in England, while Mary, husband Peter and at least five of their younger children immigrated to South Africa in 1909.

Charles Spriggs, being the eldest son, remained on the farm at Plomer Hill, and married Ellen Field in 1894. Charles died in 1928 and Ellen in 1931. Charles and Ellen had two sons, John Powesland Spriggs and Charles Powesland Spriggs, born in 1895 and 1896 respectively. I have no idea where the Powesland name came from, as it does not appear as a surname in either family back several generations.

John P. Spriggs remained in West Wycombe and married Bessie Harvey in 1931. John and Bessie did not have any children together, but John fathered a child (Susan Margaret Catling) with a widow named Winifred Catling, in Princes Risborough in 1952. John P. Spriggs died in West Wycombe in 1958, and Bessie died in Dorset in 1975.

Susan was adopted by John and Joan Orton, was raised as Susan Jane Orton and is now known by her married name, Jane Roach. She lives in West Sussex.

Charles P. Spriggs married Fanny Townsend, daughter of a local vicar, but this marriage ended in divorce in 1936. Charles P. Spriggs then married Doris Palmer in 1937. Their marriage produced two children – Gillian Rose in 1940 and Charles Andrew in 1947. Charles, Doris and family lived at Benson, Oxfordshire, and later at the New Inn, Blewbury, Berkshire. After Charles P. Spriggs' death in 1954,

Doris and her daughter Gillian emigrated to New Zealand, where Doris died in 1985 and is buried in the Anglican churchyard in Keri Keri. Jane and Gillian were unaware of each other's existence until DNA testing revealed the genetic connection between them early in 2020.

Amy Spriggs married William Henry Collins in London in 1876 and had seven children, who were all born in the Wycombe area. William Collins died in 1924 and Amy died in Brentford, Middlesex in 1946.

Hamp Spriggs married Helen Hill in London in 1888 and had two children, Edith and Wilfred, who were both born in Kingston Blount, Oxfordshire. Hamp was a grocer, draper and sub-postmaster in Kingston Blount, and died 24 October 1939, just two and a half months after Helen's death.

Bridgewater Spriggs married Florence Hall in 1895, and they had four sons – Stewart, Arnold, Norman and Cyril. Bridgewater ran a furniture manufacturing / upholstery business in Wycombe, and died in 1951, four years after Florence's death. Stewart died in Palestine during World War I. Arnold died as a baby and Cyril died in a motorcycle accident in 1928. Norman married and had a daughter named Barbara.



Lizzy Spriggs (1869– 1959).

Lizzy Spriggs married Charles Henry Cherry in London in 1892. Soon after their marriage Charles and Lizzy immigrated to the United States of America. Their two children, Gertrude and Linden were born in Chicago, Illinois in 1893 and 1896 respectively. The family moved to Benton Harbor, Michigan, where Charles died in 1941. Lizzy then moved to California and died in Los Angeles in 1959. Lizzy and Charles have descendants still living in California.

Below I have provided the basic details that I have on the descendants of Charles Spriggs and Mary Ann Bridgewater, but I have limited the details to four generations (on most lines) in an effort to avoid detailing living people –



Chapter 11 – Arthur Douglass Spriggs and Elsie Elizabeth Preston



Arthur Douglass Spriggs was born in High Wycombe, Buckinghamshire, England on 23 March 1893, the last child of Thomas and Sarah Spriggs to reach adulthood. His younger sister Gertrude had died as a baby.

In 1911 Arthur left High Wycombe and headed to Saskatchewan, Canada, to join his brothers Alfred and Henry (Hamp) in Duck Lake. In 1912 he applied for a homestead on the front of the SW quarter of Section 33, Township 45, Range 6, West of the 3rd meridian. He worked his property in the summer months and helped his brother Alfred in his butchery business in the winter.

The First World War broke out in 1914, and on 8 June 1915 Arthur signed up to serve in the Canadian Overseas Expeditionary Force, attesting at Saskatoon, Saskatchewan. The then 22 year old butcher is recorded on the attestation papers as being 5 ft. 7 $\frac{1}{2}$ in. tall, with fair hair and blue eyes. After agreeing to the nature and terms of engagement, agreeing to be vaccinated, and passing the medical inspection he was deemed fit for service.

Arthur did not immediately go overseas, as on 6 November 1915 he married Florence Edna Reid in All Saints Anglican church in Duck Lake. But just two weeks later, on 23 November 1915 he sailed for England with the 5th Canadian Mounted Rifles, and by January of 1916 he had joined the fighting in mainland Europe.

The war was not kind to Arthur, but he did survive it. On 31 May 1916 he was hospitalized due to trench fever while serving at Ypres in Belgium, returning to the trenches on 22 July. The

battalion moved to France, and in September he was promoted to Lance Corporal, whilst serving at the Somme. In October, still fighting at the Somme, an exploding shell buried him in a dugout from which he suffered a contusion of the back and shell shock, which took him out of the fight. Arthur spent six months in hospital in England, and on leaving hospital he returned, at his own request, to the ranks. He served in England for the remainder of the war and returned to Canada in May 1919, after 3 ½ years away, to find his wife and her 6 month old daughter living with another man.

On leaving the army, Arthur moved to Saskatoon and joined the Canadian Post Office as a mail clerk, a position he held until his retirement in 1958. Arthur settled into life in Saskatoon, joined the choir at the local Anglican church, and it was here that he met Elsie Elizabeth Preston. Elsie was also born in England, and had come to Canada with her parents and her brother Ted in 1908.

Arthur Spriggs and Elsie Preston were married on 14 September 1929 at the Knox United church in Saskatoon, Saskatchewan. On the marriage registration, both listed their religion as Anglican, so we can only guess that the Anglican minister perhaps would not marry a divorced person, even one who sang in his choir, hence their marriage in the United church. After their wedding, Arthur and Elsie lived at 914 – 5th Avenue North, just down the street from Elsie's parents, who lived at number 901. Here they raised two children, Gerald, born in 1931 and his younger sister, Gladys. During the summer months the family would spend time at Waskesiu Lake in Prince Albert National Park, along with the family of Arthur's brother, Alfred.

In the late 1970s Arthur and Elsie moved from their home of 30 years into an apartment just a few blocks away. It was here that Arthur died in 1981 and Elsie in 1998. Both are buried in the Woodlawn cemetery in Saskatoon.

Gerry joined the Royal Bank of Canada in Saskatoon at 18 years old and continued working in the bank until his retirement in 1987, never staying in one city for more than a few years at a time. He was working in Rosetown, Saskatchewan when he met Fredda Sim, and they married in Rosetown in 1953, as Gerry was being transferred to Foam Lake, Saskatchewan. They moved to Foam Lake the following week, and it was there that their daughter Marlene Lynn (my wife), and son, Arthur William, were born, before Gerry was transferred to Regina (1957), Montreal (1965), Calgary (1966), Montreal (1969), Toronto (1976) and Winnipeg (1982). Their third child, Robert Gerald, was born in Montreal. After retirement, Gerry and Fredda relocated to Cloverdale, British Columbia, to enjoy the coastal climate. But Gerry's golden years were cut short and he died in 1989 at his daughter's house in Calgary, and he is buried there in the Queen's Park cemetery.



Gladys Spriggs Nursing Graduation.


Gladys graduated as a nurse and spent her career working in hospitals and care facilities. She married Mervyn Smith in Saskatoon in 1959, which is where they raised their two sons, and where Mervyn died in 1991 after a career in the City of Saskatoon Electrical Department.



To respect the privacy of the living family members, this is where I will end the story of the Spriggs family's 200+ year journey from Toot Baldon, Oxfordshire, through Buckinghamshire and on to Canada, leaving the next generation to continue the story at some point in the future.

All that remains is one last chapter to provide brief details of the lives of the other children of Thomas Spriggs and Sarah Annie Barton, and an addendum to identify other Spriggs families from the Toot Baldon area that I have not yet been able to identify a connection to.

Chapter 12 – Other children of Thomas Spriggs & Sarah A. Barton



Bertha Nellie Spriggs was born in High Wycombe in 1917 and married James Lunn, a soldier, in 1917. They do not appear to have had any children. At some point Bertha travelled to South Africa, as while travelling from Cape Town to Liverpool on the M.V. Ambosso, she died on 29 October 1942 when the ship was torpedoed by German submarine U-575, 589 nautical miles north of the Azores.

Alfred Spriggs, the eldest son to survive to adulthood, was born in 1881. He served with British forces in the South African (Boer) War, before emigrating to Duck Lake, Saskatchewan, Canada. In 1905 he married Laura Kennedy and they produced 9 children. Alfred and Laura have numerous living descendants, many of whom are still in Saskatchewan. Alfred operated a butchery business, a skill that he no doubt learned from his maternal grandfather, Charles Barton, back in High Wycombe. He died in 1962 and Laura died in 1973. Both are buried in the Duck Lake cemetery.

Stanley George Spriggs was born 21 April 1882. He worked as an upholsterer and married Rose Gomme in 1905. Stanley and Rose raised 4 children, with their second son, Ronald Stanley, dying in an automobile accident in 1937. The remaining 3 children all married and had children of their own.

Eva Spriggs was born in 1884 and worked as a boot shop assistant, before marrying Robert Reid in Falkirk, Scotland in 1908. Eva and Bob Reid raised 4 children in Scotland, and Eva died there in 1971.

There are avid family historians in several other branches of descent from Mary Spriggs, and I hope that at some point they may add additional chapters to this document, expanding the story of their Spriggs lines. In the meantime, I hope that I have provided a useful outline of these families.

I apologise for any errors that may have crept into the document, and I welcome any corrections or other feedback.


Addendum – Unconnected Spriggs Families

As mentioned in chapter 1, there are several Spriggs individuals and families in the Toot Baldon area who I have not been able to connect to James Spriggs (1757–1822), the son of Mary Spriggs. What is apparent is that Richard was a very popular name for Spriggs males and that Spriggs males had a penchant for marrying females named Mary, complicating the grouping of individuals into families.

There is one large grouping, who are descendants of a John Spriggs, born around 1750 and who was buried in Toot Baldon in 1814. Several descendants of James Spriggs (1757-1822) share autosomal DNA with descendants of John Spriggs (1750-1814), suggesting that they may collectively share a common ancestor. How the two families are related is unclear, but there is data available that when viewed collectively, suggests how the families may be related –

- A Richard Spriggs, son of Richard and Mary, was baptised at Toot Baldon in 1748.
- No baptism has been found for John Spriggs (1750-1814)
- James Spriggs (1757-1822) was a son of Mary Spriggs.

Due to the proximity of birth dates of the three men named above, and a lack of other Spriggs baptisms in Toot Baldon / Marsh Baldon, in this time period, my best guess is that the three men are siblings, children of a Richard and Mary Spriggs, and that perhaps Richard Spriggs died before the birth of son James in 1757, explaining why James was listed as the son of Mary Spriggs. This suggested relationship is shown in the chart below, along with the DNA connections identified to date –
