Introduction

I began tracing the history of my Cosgrave family in the 1970s. In 1985 I was fortunate to visit the L.D.S. Family History Library in Salt Lake City, Utah, and in 1996 & 2019 I visited the Public Record Office of Northern Ireland (PRONI) and the Linenhall Library in Belfast. These repositories have collectively provided most of the information in this document.

Additional information was the result of the tireless efforts of Peter George Maurice (Maurice) Cosgrave of Auckland, New Zealand (who passed away in 2001), including research that he commissioned with the Ulster Historical Foundation.

More recently, the digitization of historical newspapers & other records, and the availability of consumer-friendly DNA testing for family historians has brought additional information to light.

The surname Cosgrave, and similar surnames (Cosgrove, Cosgriff, etc.) are generally thought to be derivatives of the Irish surname O'Coscraigh, and that may be true for the vast majority of the Cosgraves out there, who historically have adhered to the Roman Catholic religion. My Cosgrave line was Unitarian as early as the 1700s, and being from County Antrim, it suggests that perhaps they were of Scottish origin, or perhaps they were Irish and changed religious affiliation.

This document is intended to provide a general overview of the many descendant branches of our Cosgrave family tree. There will be more information on my immediate family, and their story, as that is what I am most familiar with, but I hope that it will also provide a better understanding of the other descendant lines, and how we are all related.


Throughout the document, to protect their privacy, I have tried to avoid providing details of living relatives, and I apologize if this cut-off has not been perfectly executed.

This is not intended to be the final word on the Cosgraves of Malone, and perhaps one day new records might emerge, and open up new research possibilities, I certainly hope so.

My hope is that at some point, people from other descendant branches might add additional chapters to this document, expanding the story of their Cosgrave lines.

I apologise for any errors that may have crept into the document, and I welcome any corrections or other feedback.

The chart on the next page shows with yellow highlight the ancestral line that is the focus of this document.



Irish Jurisdictions

The structure of the various levels of governance in Ireland is very complex to the outsider, and records may be grouped at any level, making research challenging for the unfamiliar (such as myself). Some understanding of the breakdown may be useful to the reader.

Ireland is comprised of four provinces based on ancient kingdoms – Ulster, Leinster, Connaught and Munster. Antrim is one of the six counties of Northern Ireland that comprise the Province of Ulster.

Generally, Irish counties are divided into civil parishes, but a civil parish may cross county boundaries. Religious records are based on ecclesiastical parishes, the names and boundaries of which may differ from the civil parishes, and these may also cross county boundaries.

The provinces are also divided into baronies, which were originally based on clan territories, and sometimes used as a jurisdictional division for tax collection records.

Poor Law Unions were introduced in 1838 to administer poor relief, and are centred on market towns.

Civil records of births, deaths and marriages (from 1864, except protestant marriages which began in 1845) are grouped into Superintendent Registrar's Districts and Registrar's Districts, based on the Poor Law Unions.

Chapter 1 – The Early Years

I have traced my Cosgrave lineage back to a Thomas Cosgrave, living at Upper Malone, just a few miles south of Belfast, County Antrim, Ireland, who was born about 1769, and who will be covered in more detail in chapter 2 of this document. But what of the earlier generations?

Land has always been very important to the Irish people, and records of transactions regarding the land are a major source of information. Landowners recorded leases of land to tenants, and Indentures of Lease were registered to document transfer of land occupancy from one person to another.

King James I, in a patent dated 5 November, 1603, granted Belfast Castle and a large area around it, to Sir Arthur Chichester for his part in defeating the Irish in Ulster. Following the "Flight of the Earls" in 1607, Chichester became obsessed with the Plantation of Ulster with Protestant lowland Scots. The Chichester family continued to dominate Belfast for several generations, and provided land for the plantation settlers through lease, retaining ownership of the land themselves. Leases were generally short, until the 5th Earl of Donegall (created 1st Marquis of Donegall in 1791) began offering longer leases in 1767.

One such lease was granted to Daniel Cosgrave of Belfast on 20 June, 1770, for the term of three lives or 41 years. The lease covered 14 acres and 30 perches in the townland of Upper Malone at an annual rent of 13 pounds and ten shillings, and began as follows:

Lease of 14 a. 0r. 30p. in Upper Malone for 3 lives or 41 years from 1st May 1770.

Signed, sealed and delivered by the Earl of Donegall in the presence of Geo. Portis David Henderson (not signed by Daniel Cosgrave) Signature and Seal of Donegall

This indenture made the 20th day of June in the year of Our Lord one thousand seven hundred & seventy; Between the Right Honourable Arthur, Earl of Donegall, of the one part, and Daniel Cosgrove, of the Parish of Belfast in the County of Antrim, his heirs ...all that farm, tenement or parcel of land in Upper Malone, containing by admeasurement fourteen acres and thirty perches plantation measure or thereabouts, be the same more or less, and now in the occupation of the said Daniel Cosgrove ...{lease continues}.

The 1st Marquis of Donegall became desperately short of money. To raise immediate cash he began renewing leases at the same rent, but with a 'fine' payable upon the renewal. Many

tenants could not afford the fines, and were evicted from the land.ⁱⁱⁱ The lease to Daniel Cosgrave was renewed to Alexander Cosgrave on 18 December, 1800 for 61 years at the same rent, but with a fine of forty five pounds and ten shillings.^{iv} Alexander Cosgrave was obviously one of the luckier tenants, in that he could afford the 45 pound fine. The lease begins as follows:




Attached to this lease in 1800 was a sketch showing the property orientation, the occupants of the bordering properties and the townland boundaries. This showed that the parcel of land occupied by the Cosgrave family, was bordered on the northwest by the townland of Lower Malone, on the north by the lands of Donald McNeal, and on the south and east by the lands of John Campbell. A tracing of this sketch has been reproduced below:



Sketch of Cosgrave farm (1800).

By comparing the sketch attached to the lease of 1800 with the oldest available Ordnance Survey map (1831)^v, the location of the property can be identified. The property was situated on the East side of the Old Road to Lisburn, north of Stockman's Lane. Due to the shape of the townlands, this is the only area within Upper Malone where a property lies southeast of the Lower Malone boundary with Upper Malone.

The Ordnance Survey map of Upper Malone in 1831 has been reproduced on the following page:

This location was later confirmed by reference to a map^{vi} of the Antrim Estates of the most noble, The Marquis of Donegall. Over the years, the names of the roads have changed. The Old Road to Lisburn is now Malone Road, and the section of Stockman's Lane adjoining Malone Road is now Balmoral Avenue. The Cosgrave family property lies on the East side of Malone Road, between Deramore Park South and Newforge Lane, as shown on the more modern map shown below^{vii}:

So we know that Daniel Cosgrave was living in Upper Malone in 1770 and possibly earlier, and that the lease on the 14 acre farm that he held, was renewed to an Alexander Cosgrave in 1800, suggesting that Daniel had recently died and his son (or possibly his brother or nephew), Alexander Cosgrave, had taken over the farm.

Daniel and Alexander Cosgrave are mentioned in several articles that I have not yet reviewed in indexes to the Belfast News-Letter newspaper. The Belfast News-Letter has been indexed from 1737 to 1858, with the index from 1737 to 1800 being available online viii, and the index for the remaining years being available at the Linenhall Library in Belfastix. In the online index, every significant word and date in the 20,000 surviving pages of the newspaper was indexed. The final database of information contains nearly 300,000 items of news and advertisements.

A T this awful period, when a most savage and unna-tural Rebellion has broken out in some parts of this Kingdom, the Inhabitants of that Diffrict of Country. between Belfast and I isburn, think a general Declaration of Loyalty and Fidelity to his Majesty and the Constitution absolutely necessary. We, whose names are hereunto subscribed, in the prefence of God, do folemnly deciare our utter abhorrence and deteftation of all Foreign Interference in the Affairs of this Kingdom, of the atrocious Infurrection now existing in it, and of all feeret Cabals and privy Conspiracies to subvert or new model the Constitution, without the joint confent of King, Lords, and Commons in Parliament; and that we will use our utmost endeavours to deseat the defigns of all feditions and difaffected persons; whether existing under the denomination of United Irishmen, or other traitorous Affociation. 


One article from the Belfast News-Letter that I did review was a list of people swearing loyalty to the British Crown during the 1798 Rebellion. The article appeared in the newspaper on 26 June 1798 and is shown to the left. The list of Loyalists includes Alexander Crossgrave, Thomas Crossgrave, James Steele and William Steele.

The lease on this 14 acre farm at Upper Malone, was renewed to Thomas Cosgrave in 1828, and will be discussed further in chapter 2.

Based on the three land leases discussed above, the most likely scenario, and therefore the relationships that are at this time assumed, would be that Alexander Cosgrave was the father of Thomas Cosgrave and Daniel was the grandfather, as shown below. This is supported by additional DNA evidence which came to light in 2024 (see chapter 17).



Chapter 2 – Thomas Cosgrave and Margaret Steele



We know from probate records and newspaper notices that Thomas Cosgrave died 24 October 1854 at the age of 85 years, and was buried in the Drum Burial Ground. He was therefore born circa 1769. His place of birth is not known, and lacking evidence to the contrary, we assume that his father was Alexander Cosgrave, and that Alexander was in turn a son of Daniel Cosgrave, the two earlier occupants of the 14 acre farm in Upper Malone. This would be in line with the Irish tradition for naming the eldest son (Alexander) after the paternal grandfather. Following the same tradition of naming the second daughter after the paternal grandmother, Thomas' mother would have been named Eliza.

Thomas Cosgrave married Margaret Steele, daughter of James Steele, sometime before 1803 and the marriage produced the following children -

- Grace Cosgrave, born before 1803 (based on birth order)
- Elizabeth Cosgrave, born circa 1804 (based on age at death)
- Isabella Cosgrave, born circa 1803 (based on age at death)
- Margaret Cosgrave, born 19 March 1808
- Olivia or Leonna or Lavinia or Levinia Cosgrave, born 1 April 1811
- Mary or Anne, or Nancy Cosgrave, born circa 1815 (based on age at death)
- Alexander Cosgrave, born before 1820 (based on birth order)
- James Steele Cosgrave, born 18 May 1820

The 1st Marquis of Donegall died in 1799, and was succeeded by his son George Augustus, Lord Belfast, the 2nd Marquis of Donegall, who had accumulated huge gambling debts. The 2nd Marquis of Donegall continued to have financial problems, and in 1822 an elaborate new settlement was made of the vast estates. Two thirds of his land was leased 'in perpetuity' with rents fixed for all timex. On 23 December, 1828, the lease on the 14 acres and 30 perches in Upper Malone was renewed to Thomas Cosgrave in perpetuity at an annual rent of 12 pounds, nine shillings and three pence, with a fee of one pound and five shillings at the fall of each of three lives^{xi}. i.e. Alexander Cosgrave, James Cosgrave and Sayers Bamford. Who were these three named people, at whose death the fee was payable? It is likely that the named people were the lessee's young sons, Alexander and James (born 1820), and a friend of very young age who was expected to live for many years. A Sayers Bamford, born circa 1824, died on 6 July 1886, is buried in the grounds of the Dunmurry church, and is likely the third named "life".

This lease reads as follows (the original lease contains no punctuation. Question marks indicate words that were not legible on the original document):

Memorial of an indenture of Lease bearing date the first day of May in the year of our Lord one thousand eight hundred and twenty eight and made between the Most Honourable George Augustus Marguis of Donegall of the one part and Thomas Cosgrave of Upper Malone in the County of Antrim Regd. ½ past 3 farmer of the other part. Whereby the said George Augustus Marquis of of 23 of Decr. 1828 Donegall did ?? grant set and ?? let release and ?? unto the said Thomas Cosgrave for his actual possession this being by virtue of a lease for a year therein ?? and to his heirs and assigns all that farm with the several fields

pieces or parcels of land or ground to the same belonging counting by estimation fourteen acres and thirty perches plantation measure or thereabouts be the same more or less situate lying and being in Upper Malone as now in the possession of the said Thomas Cosgrave and his undertennants and as formerly demised to Alexander Cosgrave as therein ?? together with all houses ?? and buildings thereon erected or thereafter to be erected and built thereon all which said premises are situate lying and being in the Parish of Belfast Barony of Belfast and County of Antrim to hold to the said Thomas Cosgrave his heirs and assigns / except as herein excepted / for and during the life and lives of Alexr Cosgrave James Cosgrave and Sayers Bamford of Malone for and during such further to the life and lives as should forever thereafter be ??thereto by virtue of the C?? for perpetual renewal in the ?? ?? ?? and subject to the yearly rent of twelve pounds nine shillings and threepence due and a sum of one pound five shillings at the fall of each life which said lease and this memorial as to the ?? thereof by the said G. A. Marquis of Donegall are witnessed by Joseph MacArtney of Belfast in the County of Antrim Attorney at Law and John McConnell his clerk

<Donegall seal> signed sealed and delivered in presence of Joseph MacArtney John McConnell The above named John McConnell ?? ?? oath saith that he is a subscribing witness to the ?? of lease of which the above writing is a memorial and also to the above memorial and saith that he saw the said lease and the memorial were duly executed by the above named G. A. Marquis of Donegall saith that he saw the said lease also executed by the above named and Deponent saith that the name of John McConnell signed and sealed as a witness to the lease and this memorial is Deponents proper name ?? John McConnell sworn before me at Belfast in the County of Antrim this sixth day of December 1828 a Commissioner for taking affidavits in this county and I know the Deponent John Wallace {lease ends}

Living on a 14 acre farm, with a perpetual lease, Thomas Cosgrave was obviously not a poor man, but houses of the time, for such a farmer, were frugal by today's standards. The house itself probably consisted of two rooms, with a total area about 30 ft. by 15 ft., of whitewashed stone construction, and with a thatched roof. Only a quarter of the farm houses in the area had a slate roof in 1837, and only one in seven was two stories high^{xii}. The two rooms would be a kitchen and a bedroom.

There may have been a loft above the kitchen to provide additional sleeping space for the children. The house would likely have looked similar to the house shown in the photograph above.xiii

The occupiers of land were required to pay a tithe to the established church, that being the Church of Ireland. The Tithe Applotments for Malone in 1834 show Thomas Cosgrave paying tithes of one pound, six shillings and three pence to the rector, and 15 shillings and nine pence to the vicar^{xiv}.

Belfast had been a predominently English settlement until the Plantation of Ulster in the 17th century, with the Church of Ireland being the main religious denomination in the area. The

Plantation resulted in a large increase in Scottish Presbyterians, but even as late as 1707 there were only 7 Catholics living in Belfast^{xv}. The first Catholic Church in Belfast was built in 1784 with assistance from subscriptions by local Protestants, at which time there were 1092 Catholics in Belfast^{xvi}. By 1835 Belfast's 22,078 Catholics accounted for 32% of the local population, with Presbyterians accounting for 39% and Protestants 29%^{xvii}. This rapid increase in the Catholic population saw the beginning of the deterioration of the previously harmonious relations between Protestants and Catholics in the town of Belfast.

In the early 18th century, several of Belfast's Presbyterian congregations left the Synod of Ulster to form the "Non-Subscribing Presbyterian" church. The Non-Subscribers refused to subscribe to any man-made profession of faith, and were also known as Unitarians^{xviii}.

One such congregation was in Dunmurry, in the Parish of Drumbeg. Dunmurry is about three miles north of Lisburn, on the old road leading to Belfast, and about two and a half miles from the Cosgrave family's farm in Upper Malone. The congregation began in 1686, and the meeting house, which was rebuilt in 1799, is still in use today.

The old record book of the Dunmurry Congregation includes several mentions of Thomas Cosgrave and his father in law, James Steele, which provides evidence that the families were adherents to the Unitarian doctrines:

- 1. James Steele was appointed to the committee in 1807.
- 2. Thomas Crosgrave was one of 22 members who invited the Rev. Andrew Malcolm to become their minister.
- 3. Thomas Crossgrave was one of 10 members appointed to the committee in 1807.
- 4. On August 2nd, 1807, James Steele was appointed to attend a meeting of Presbytery at Dundonald, the following Tuesday.
- 5. On January 31st, 1808, Thomas Crossgrave was appointed to attend a meeting of Presbytery at Belfast, the following Tuesday.

The old record book also provides details of the baptisms at Dunmurry from 1807 to 1812, and 1815 to 1817^{xix}. The surviving baptism records include two children of Thomas Cosgrave:

- 1. Born March 19th, 1808, Margaret, daughter of Thomas Crosgrave of Malone
- 2. Born April 1st, 1811, Livy, daughter of Thos Crosgrave of Malone

Livy Cosgrave is not found in any later records, but her father's will refers to a daughter named Olivia, and other records refer to a Leonna, Lavinia and Levinia Cosgrave. I believe all of these people to be the Livy Cosgrave baptised in 1811, the fifth child of Thomas Cosgrave and Margaret Steele.

The names of the children of Thomas Cosgrave and Margaret Steele, who were alive at the time of Thomas's death, were obtained from his will, and the order they are listed in the will is assumed to be the birth order.

The eldest child of Thomas and Margaret Cosgrave was Grace, who appears to have married twice, but I have found no record of children from either marriage.

The index to the Belfast News-Letter newspaper at the Linenhall Library, Belfast^{xx} identifies that Grace, eldest daughter of Thomas Cosgrave, Malone, married 29-Jun-1824, but does not provide the name of her husband.

A second entry states that Grace, eldest daughter of Thomas Cosgrave, Malone, married George Wood of Woodville, on 23 November 1838.

The Wills Index on the Public Record Office of Northern Ireland (PRONI) website^{xxi}, states that "Letters of Administration of the Personal Estate of Grace Woods formerly of Derryaghy and late of No. 36 Ann-street Belfast in the County of Antrim Widow deceased who died 28 May 1859 at Ann-street aforesaid were granted at Belfast to Anne Anderson (Wife of Joseph Anderson) of Ann-street aforesaid Innkeeper the sister one of the next of kin of said deceased. Date of Grant 18 June 1859; Effects under £600".

The sixth child, and youngest daughter, of Thomas and Margaret Cosgrave, also married twice, and does not appear to have had any children. The Belfast News-Letter of 9 October 1835 states that Mary, youngest daughter of Thomas Cosgrave, Malone, married Joseph Anderson of Cullentree Place

The Belfast civil marriage record of James Cain and Anne Anderson, dated 16 November 1866, states that Robert Cain married Anne Anderson, alias Cosgrave, widow, daughter of Thomas Cosgrave. The will of Thomas Cosgrave does not mention a daughter named Mary nor a daughter named Anne, but it does mention a daughter named Nancy Anderson. I believe that Anne, Mary and Nancy are the same person, and that the 1835 newspaper entry is a misprint.

Alexander Cosgrave, is mentioned before his brother James in the will of Thomas Cosgrave, so is believed to be the seventh child and eldest son of Thomas and Margaret. There is no evidence that Alexander Cosgrave married. He made his will on 17 October 1857 and died the same day, leaving his estate to his sister Olivia, and Thomas, the son of his brother James, who was residing with him.

The remaining children of Thomas and Margaret Cosgrave all married and had families of their own, which will be covered in later chapters.

All Irish wills probated up until 1858 were stored at the Four Courts Building in Dublin, and almost all were destroyed during the fire associated with the civil war in 1922. The only


exceptions, fortunately, are the will books for the Diocese of Down and Connor, the Diocese that includes Malone. The indexes to wills in the Diocese of Connor^{xxii} indicate two Cosgrave wills of interest, and both of these wills have been located:

- Cosgrave, Thomas, of Malone, probated in 1855
- Cosgrave, Alexander, of Malone, probated in 1858

The Irish Wills Index (1838-1845)^{xxiii} indicates that when the will of Thomas Cosgrave was probated in 1855, the Executor of the will was James Anderson of Belfast.


The will of Thomas Cosgrave^{xxiv} was written on 11 October 1852. At this time, two executors were named - "sons-in-law James McCreight and James Anderson". This document identifies the name of his wife - Margaret Cosgrave, otherwise Steele, and the names of his children living at that time - Alexander Cosgrave, James Steele Cosgrave, Grace Woods, Eliza McCreight, Isabella Campbell, Margaret Anderson, Nancy Anderson, Olivia Cosgrave. This will left his estate to his wife, Margaret, with specific bequests of 160 pounds to each son, and 40 pounds to each daughter. On the death of his wife, the estate was to be divided into eight equal shares for his children.

As stated at the beginning of this chapter, Thomas Cosgrave died 24 October 1854 at the age of 85 years, and was buried in the Drum Burying-ground.




Thomas Cosgrave death notice.


His wife, Margaret, lived on for three years, and died on 5 October 1857 aged 82 years. She too was interred in the Drum Burying-ground.

Chapter 3 – Elizabeth Cosgrave and James McCreight



Elizabeth Cosgrave, the second child of Thomas Cosgrave and Margaret Steele, married James McCreight some time before 11 October 1852, as Thomas Cosgrave's will, bearing that date, identified his daughter as Eliza McCreight and named James McCreight as one of his executors.

The Belfast News-Letter of December 7th 1891 identified that James Anderson was in the Court of Chancery^{xxv} battling with Robert Thompson, a great grandson of Thomas Cosgrave, through Eliza Cosgrave, wife of James McCreight, regarding the estate of Thomas Cosgrave. Robert argued that as Olivia Livingston (daughter of Thomas Cosgrave) died without issue, then her share of her father's estate was now available for redistribution to the other beneficiaries of the estate, and as his mother and grandmother (Eliza Cosgrave) were also both now dead, he (and his brothers and sisters) should receive his grandmother's share of the estate. The case required a ruling on whether the word "issue" as used in the will of Thomas Cosgrave, meant children, or, children & grandchildren of children. The court found against Robert Thompson, ruling that "issue" in Thomas Cosgrave's will referred only to his children, and not to their children and grandchildren.

I am aware of two children of Eliza Cosgrave and James McCreight, as follows -

- Ann Jane McCreight, born circa 1840
- Margaret Anne McCreight, born circa 1845

Their married names were obtained from court case files and probate files which will be discussed in later chapters, which led to their subsequent marriage and death records.

I have not researched these lines extensively, so do not have a lot of detail of their descendants, but what I do know is as follows –



Chapter 4 – Isabella Cosgrave and Henry Campbell




Isabella Cosgrave, the third child of Thomas Cosgrave and Margaret Steele married Henry Campbell in 1831. The couple had two known children as follows –

- Alexander Campbell


The children's names were obtained from the probate record of Isabella and the death certificate of Henry, respectively.

The informant on the death certificate of Isabella Campbell, nee Cosgrave, was a granddaughter named Ellen Holmes, but it is unknown which child of Isabella was her parent.

Chapter 5 - Margaret Cosgrave and James Anderson



We know that Margaret was the fourth child of Thomas Cosgrave and Margaret Steele, as this was stated on the newspaper notice of her 24 December 1829 marriage to James Anderson, a local builder.

Thomas Cosgrave Anderson emigrated to Australia and Cosgrave is found as a second given name of some of his descendants.

Similarly, Samuel Cosgrave Anderson immigrated to New Zealand, and Cosgrave is found as a second given name of some of his descendants. I believe that Samuel was in Auckland, New Zealand when Margaret Cosgrave's younger brother, James Steele Cosgrave arrived there in 1864.

The fifth child, Margaret Anderson, married and had children in India, but returned to Ireland before 1885.





Chapter 6 - James Steele Cosgrave and Anna O'Neill



James Steele Cosgrave was named after his maternal grandfather, James Steele, who was born around 1736 and died on 8 October, 1823. The Cosgrave family biblexxvi identifies that James Steele Cosgrave was born 18 May 1820.

The Presbyterian community built the Belfast Academy in 1786 to provide a liberal education to the sons of gentlemen who could not conveniently send them to college^{xxvii}, and in 1814 the Belfast Academical Institution was established to provide education to the middle and lower classes of society, and to make provision for the education of both sexes^{xxviii}.

The records of the Belfast Academical Institution^{xxix} show that James Cosgrave, son of Thomas Cosgrave of Malone "commenced arithmetic in November 1837 and left-off in February 1838".

In 1844, James Steele Cosgrave enrolled at the Belfast Medical School, from which he graduated in April 1846 with a Diploma in Midwifery and Diseases of Women and Children^{xxx}. He setup as a Surgeon in nearby Holywood, County Down, in 1847.

Belfast Medical School.—On the 9th instant, after a lengthened and minute examination, before the medical faculty, the following gentlemen of Dr. Burden's class, were adjudged diplomas in midwifery, and diseases of women and children:—James S. Cosgrave, Malone;

James Steele Cosgrave - notice of graduation.

Later that same year, James Steele Cosgrave of Malone (the son of Thomas Cosgrave) married Anna O'Neill of Belfast, on November 16th, 1847 at the Unitarian meeting house in Dunmurry. Anna O'Neill is listed as a 25 year old spinster, residing at Lime Kiln Dock, Belfast, daughter of John O'Neill, a merchant. The marriage entry is reproduced below^{xxxi}:

The British Newspaper Archive website^{xxxii} includes digitized copies of almost complete sets (there are some gaps) of several post-1800 Irish newspapers. This wonderful resource unearthed a series of articles regarding an 1854 case in the Court of Chancery, relating to James Steele Cosgrave's challenge to the administration of the estate of his maternal grandfather, James Steele.

The Court of Chancery case was well documented in the news media of the day, with articles appearing in at least 5 newspapers, detailing the progress of the case –

- Banner of Ulster; 28 March 1854; page 1 & 2
- Belfast Chronicle; 27 March 1854; page 2
- Belfast Mercury; 27 March 1854; page 3
- Belfast News-Letter; 27 March 1854; page 1 &2

The salient details of the Chancery case were as follows -

James Steele farmed approximately 100 acres near Dunmurry, SW of Belfast, comprised of a hill farm, of poor quality, and a lowland farm of much better quality. Here he kept cows and a few pigs, and grew crops, primarily oats. James Steele died on October 8th 1823.

It appears that James Steele had at least 7 children, 3 sons and 4 daughters, one of whom was Margaret Cosgrave (nee Steele). In his will, dated 5 May 1823, James Steele directed that a legacy of 150 pounds be paid to his daughter Elizabeth Stevenson, and that his son, Matthew Steele, was to receive the income from the remaining estate. Upon Matthew's death, legacies of 100 pounds each were to be paid to James Cosgrave (grandson of James Steele), and to Robert Steele and Thomas Steele (believed to be sons of James Steele). The residue of the estate was to be split equally between the daughters and grandchildren of James Steele, a total of 30 persons. The executor of the estate was Alexander Finlay, son in law of James Steele, who had a daughter (name unknown) by James Steele's daughter, and at least two sons, John and Robert Finlay, by a second wife.

Matthew Steele died in March 1844, at which point Alexander Finlay paid the 3 remaining legacies, and made an initial payment of 10 pounds to each of the 30 beneficiaries of the residual estate, including 90 pounds paid to Thomas Cosgrave (10 pounds for his wife Margaret, and 10 pounds for each of his 8 children). A second payment of 7 pounds, 17 shillings and 4 pence was paid to the 30 beneficiaries in August 1844. One beneficiary, William Stevenson (son of Elizabeth Stevenson named above), was not paid as he was out of the country, and the money could not be safely transferred, so was held for him to claim.

Alexander Finlay died on 9 March 1851, and his son, John Finlay, as his executor, became the acting executor of the estate of James Steele.

In 1852, Elizabeth Stevenson (nee Steele) wrote from New York to ask if her son, William Stevenson, had received his share of the estate of James Steele. This prompted James Steele Cosgrave to seek a copy of the will of James Steele, which he claimed to have not previously seen, and to guestion the administration of the estate of James Steele.

After unsuccessfully seeking information directly from John Finlay regarding the administration of the estate of James Steele, James Steele Cosgrave sued John Finlay, as the acting executor of the estate of James Steele, making two claims –

- That the inventory of the estate of James Steele, as documented by Alexander Finlay, was incomplete, effectively claiming that Alexander Finlay had kept significant livestock and crops for himself, to the detriment of all beneficiaries of the estate.
- That he, James Steele Cosgrave, had not received his share of the residual estate, although he acknowledged receipt of the 100 pound legacy.

James Steele Cosgrave was represented by Ross Moore Q.C., and John Finlay was represented by Mr. Joy Q.C.

Rev. Dr. Montgomery, minister of the Dunmurry Unitarian church, testified that he tried to convince James Steele Cosgrave to not proceed with the suit, as, even if he won, his costs would be greater than the amount that he would receive from the defendant, but to no avail.

James Steele Cosgrave believed that he had been wronged and was willing to go to jail if he had to.

The first claim in James Steele Cosgrave's suit relied heavily on the evidence of William M'Connell, who had worked on the farm of James Steele prior to, and after, the death of James Steele, and who stated that there were 27 or 28 cows on the farm at the time of James Steele's death, and a substantial quantity of hay and oats.

The second claim relied on the evidence of James Steele Cosgrave himself, who stated that when he received his legacy of 100 pounds, his father was also given 90 pounds, and that he, James Steele Cosgrave, was told by Alexander Finlay at that time, that he had no further claim, which he did not discover was incorrect, until he saw the will of James Steele in 1852.

The defence portrayed William M'Connell as an unemployed pauper, whose memory of the events could not be relied upon. They also called the purchaser of the property to give evidence of how many cattle the farm could support (less than claimed by M'Connell), and questioned why, as Thomas Cosgrave was too ill to appear in court, his wife, Margaret Steele, did not appear as she had always had a copy of the will, was on the farm at the time her father died, and so should know first-hand what transpired. The icing on the cake was that they produced the inventory books deposited at the Stamp Office by Alexander Finlay, and the receipt from the auctioneer, which collectively suggested that Alexander Finlay had faithfully executed his responsibilities as executor. John Finlay explained that Thomas Cosgrave received the residual amount for his wife and all 8 of his children (90 pounds + 64 pounds, 19 shillings), including James Steele Cosgrave's share, and even if James did not directly receive the money, he received the benefit of the money, as his parents had paid his lodging in Belfast and the cost of his medical schooling.

The jury took only a half hour to find in favour of the defendant, and James Steele Cosgrave was later ordered to pay court costs of 154 pounds.

Soon after the Court of Chancery decision, Thomas Cosgrave added a codicil to his will, revoking the bequest of 160 pounds to James Steele Cosgrave, and providing a bequest of 1 shilling instead. The timing of this codicil suggests that Thomas Cosgrave was not happy with his son's action taken in the Court of Chancery, regarding the estate of his maternal grandfather, James Steele, and so effectively dis-inherited his son. Thomas Cosgrave died that same year.

It appears that around the time of his brother's (Alexander) death, James Steele Cosgrave moved back onto the family farm in Malone, as the Belfast Mercury^{xxxiii} of 16 March 1858 reported an action of ejectment brought by James Anderson against his brother in law, James Steele Cosgrave, to recover possession of a farm land at Malone, but James Steele Cosgrave consented to vacate the property, avoiding a trial.

James Anderson then proceeded with the sale of the farm at Malone, as a notice in the Belfast Mercury^{xxxiv} of 27 October 1858, offered "Cosgrave's Farm" at Malone for sale, identifying it as "Building Ground". The farm fell victim to the suburban sprawl of the City of Belfast, and was subdivided for housing.

A further notice published in the Northern Whig^{xxxv} of 18 July 1860, by James Anderson, stated that the 14 acre property at Malone had been sold to Henry Russell of Belfast, a solicitor, and asking anybody who objected to the sale to come forward.

The Belfast News-Letter^{xxxvi} of 5 March 1862 contained a notice stating that James Cosgrave was an insolvent, and called for creditors of the late Thomas Cosgrave of Malone to identify their claims on the estate.

The Evening Freeman^{xxxvii} of 4 September 1863 gave notice of a meeting of the creditors of James Cosgrave to be held in Dublin on October 10th to review the accounts and to make a first and final dividend.

Having lost badly in the Court of Chancery, and forced to declare bankruptcy, James Steele Cosgrave, likely with some encouragement from his siblings, packed up his family and emigrated from Ireland to New Zealand, but before we look at the family's life in New Zealand, we will introduce the children of James Steele Cosgrave, who were all born in Ireland.

James Steele Cosgrave and Anna O'Neill had seven children, born as follows –

- Thomas Cosgrave, born circa 1848
- Margaret Elizabeth Cosgrave, born circa 1850
- James Alexander Cosgrave, born 23 March 1851
- Theresa Anne Cosgrave, born 26 September 1853
- Alfred Edward Cosgrave, born circa 1854
- Norman Cosgrave, baptised 15 July 1859
- Ida Olivia Cosgrave, born circa 1860

All seven children travelled with James and Anna Cosgrave, when they sailed to New Zealand on the ship *Ida Ziegler*, in 1864. The New Zealand Herald newspaper of 29 October, 1864 announced the arrival of the *Ida Zeigler* in Auckland, and provided a list of passengers. This passenger list includes:

Jas., Hannah, Thomas, Mary E., James A., Theresa, Alfred, Norman, and Olivia Cosgrave.


Margaret Elizabeth (Mary E. in the passenger list) died in Auckland at age 16, from Peritonitis, on the 23rd of March, 1866.

James Steele Cosgrave lived in Auckland for some years and later moved to Kaukapakapa, after he was appointed Government Vaccinator for the area. He died from influenza in Kaukapakapa on the 5th of August, 1894.


Hannah (Anna), his wife, died three days before her husband, also from influenza, and is buried with him in the Kaukapakapa cemetery.

Their son Thomas became a farmer, did not marry, and died of pancreatic cancer in Auckland hospital on 31st of December, 1900. He is also buried at Kaukapakapa.


The lives of the other children of James Steele Cosgrave and Anna O'Neill will be investigated further in following chapters.



Chapter 7 – James Alexander Cosgrave and Ellen Meale



James Alexander Cosgrave was born 23 March 1851 at Ballylesson Cottage, the third child of James Steele Cosgrave and Anna O'Neill. Notice of his birth was found in the Belfast News-Letter newspaper of 28 March 1851.

At the age of 13 years, he emigrated from Ireland to New Zealand with his parents and siblings, on the ship *Ida Ziegler*. After initially living at Auckland, the family moved to Kaukapakapa.

James Alexander Cosgrave, a 25 year old mariner, married 19 year old Ellen Meale, in the Wade Registry Office on 17 June 1878, and James worked as a bushman before taking up farming. The marriage produced 8 children, born as follows –

- Annie Elizabeth Cosgrave, born 23 August 1880
- Ellen Olivia Cosgrave, born 22 June 1882
- Edith Steele Cosgrave, born 14 December 1884

Sidney James Cosgrave married Edith Rosalia Schischka on 21 July 1906 and they had 3 children together, Muriel Joy, Edith Bernice Elizabeth, and Peter George Maurice (Maurice) Cosgrave. This marriage ended in divorce in 1930 and Sidney had three additional children with Una Jessie Leslie – June, Margaret, and John James Steele Cosgrave. Sidney's known descendants are as follows –

Vivian John Cosgrave married Justine Ursula Brady and their family will be covered in more detail in chapter 12.

George Edward Cosgrave and James Steele Cosgrave (jnr.) both served in World War I and made the ultimate sacrifice. Their short lives will be covered in chapters 13 and 14 respectively.

Percy Cosgrave joined the New Zealand Police on 27 March, 1914, and was stationed at Wellington's Mount Cook Police Station. He married a widow named Imelda Coogan (nee Mooney) in the Wellington Registrar's office on 17 October, 1918. Imelda's first husband, James Hobson Coogan, had died in 1915, and they had a daughter, Mary Ellen Gertrude Coogan, who was born 24 October 1904. Percy and Imelda did not have any children together.

The Evening Post newspaper of 4 April 1921**xxviii, identifies that "Constable P. Cosgrave, who has been stationed at Mount Cook (Wellington) Police Station for the past seven years, has resigned, in order to take over the Pier Hotel, Kaikoura".

The hotel business did not go well for Percy, and on the 9th of April, 1923 he filed for bankruptcy. Percy stated that he had had bad luck with the hotels that he had gone into, and came away with nothing. His creditors received 2 shillings and 6 pence per pound owed (12.5%).

Percy took on the family farm at Upper Waiwera, but after the death of his mother, the farm was sold and Percy worked for Auckland brewers *Hancocks*, employed as a relieving manager at several hotels, notably the Astor in Auckland, the Northern Wairoa in Dargaville, and the Palace in Rotorua.

He died in Auckland on 25 September 1964, and is buried in Auckland's Waikumete cemetery. Imelda died in Wellington on 25 July 1966.


James Alexander Cosgrave and Ellen Meale farmed at Upper Waiwera, where they raised their 8 children. In April 1921, their son Percy had purchased the Pier Hotel in Kaikoura, and James Alexander Cosgrave visited Percy later that year.

James Alexander Cosgrave's death certificate identifies that he died of a cerebral hemorrhage at the Pier Hotel on 6 December 1921, and he is buried in the Kaikoura cemetery. A story passed down in the family is that James was playing with a group of children in the hotel, and fell down the stairs, landing on his head.


After the death of her husband, Ellen Cosgrave (nee Meale) continued farming at Upper Waiwera, with assistance from her son Percy. Ellen died of acute bronchitis on 13 July 1928, at the home of her sister in Cambridge. She is buried in the Cambridge cemetery.

Chapter 8 – Theresa Anne Cosgrave and Henry Hellyer







Chapter 9 – Alfred Edward / Edmond Cosgrave



Alfred Edward / Edmond, the fifth child of James Steele Cosgrave O'Neill was born circa 1854 at Holywood, County Down, Ireland. He married Euphemia Spence Lamb on 1 January 1876 at Wade, New Zealand, with whom he had 4 children before Euphemia's death at the age of 23, due to tuberculosis, on 16 February 1884 at Riverhead. Alfred subsequently had another family of 12 children with Martha Warren, between 1895 and 1917. Alfred and Martha married 24 September 1907 at Whangaroa.

Alfred worked his entire life as a gum digger and died 24 June 1927 at Parua Bay. He is buried in the Parua Bay cemetery.








Chapter 10 - Norman Cosgrave and Mary Ellen Hennessy




Norman, the sixth child of James Steele Cosgrave and Anna O'Neill was baptized at St. Anne's church in the parish of Shankill, Belfast, on 15 July 1859. 



Chapter 12 – Vivian John Cosgrave



Vivian John (my grandfather), the fifth child of James Alexander Cosgrave and Ellen Meale, was born at Upper Waiwera on 1 May 1887. Initially he worked on the family farm, but at 28 years old, he joined New Zealand Police on 29 March 1915 as a constable, and was posted to Wellington. On 10 November 1915 he married Justine Ursula Brady in the Roman Catholic church at Howick, Auckland, and the couple settled into life together in Wellington, living at 228 Tinakori Road, and it was here that all five of their children were born.

Vivian's first promotion in the police force was to a sole-charge constable position in Levin in the mid-1920s, but by 1930 he had been transferred to Hunterville. The Truth newspaper of 3 April 1930 reports that "VIVIAN JOHN COSGRAVE is the law in Hunterville and he does his job well. While he would always prefer to do a man a good turn he does not allow his kindly nature to interfere in the discharge of his duties. As clerk of the court he wields his pen and conducts his cases well, while his guiding hand controls a wide district. "Cossy" loves football and he may often be heard instructing

the young men in the rudiments of the game. He knows its "laws" and the boys listen well"xxxix.

From Hunterville, the family moved back to Wellington in 1935, living again on Tinakori Road, but this time at number 174, as Vivian was promoted to Police Sergeant. In 1939 he was transferred to Wanganui, in December 1940 to Taumaranui, and in 1944 to his final appointment, in Foxton.

Vivian retired in Foxton in 1955 after serving his 40 years with New Zealand Police. Justine had died on 2 May 1950 and is buried in the Foxton cemetery. In the mid-1960s Vivian moved to Wellington, where he lived with his daughter Noeline, until his death on 16 October 1969. He is buried in the Foxton cemetery, next to his wife and their two unmarried children.

As mentioned at the beginning of this chapter, Vivian and Justine Cosgrave raised five children, four boys and one girl. Their eldest child was my father, James Edward Cosgrave, who was born in Wellington on 9 January 1917. His life will be covered in detail in the next chapter.

The second child of Vivian and Justine Cosgrave was George Steele Cosgrave, whose life will be covered in chapter 16.

Noeline Catherine Cosgrave was the third child and only daughter of Vivian and Justine Cosgrave. Noeline was born 31 December 1920 in Wellington. She was at secretarial college in Wanganui when her father was transferred to Taumaranui, and Noeline boarded with a local Wanganui family until her studies were completed. Noeline worked in an administrative role for the New Zealand government until retirement, and she then worked for a firm of architects.

Noeline did not marry and she cared for her father in his later years. When her property on Kemp Street, Kilbirnie became too much for her to look after, she moved into an apartment on William Street, where she lived until moving to a care home when her health failed. Noeline died at 95 years of age on 28 September 2015 and is buried with her parents in the Foxton Cemetery.

Vivian John junior (Vic or Viv) was born 20 January 1923. Viv (as I knew him) joined the Royal New Zealand Air Force (70987), and was a career officer. In the 1967 New Year's Honours he received an M.B.E. (Military Division). Viv retired from the Air Force as a Warrant Officer.

He married Audrey June Martyn in 1951 and they had two sons -Gary Martyn and Paul Edward. Both sons emigrated to Australia, and after Viv retired, he and Audrey also moved to Australia, settling in Brisbane.

Viv was hit by a car while crossing the road, and died 11 April 2007. Audrey died 22 January 2014. Both are buried in Nerang, Queensland.

The youngest child, Henry Timothy (Harry) Cosgrave was born 4 May 1924. After high school Harry joined the Royal New Zealand Air Force (71779) and spent a portion of his career stationed in Singapore.

Harry married Kathleen Marjorie Jury in 1947 and the marriage produced four children – Karyn Justine, Antony John, Peter Christopher and Michael David.


He retired to the Air Force Officers Reserve List as a Flight Lieutenant on 17 February 1969 and was officially retired four years later Harry then worked for the City of Porirua, and died in Rotorua on 25 April 1987. His wife, Kathleen, died 20 October 2010 in Wellington.




Viv Cosgrave & Audrey Martyn 1951wedding.

Chapter 13 – George Edward Cosgrave



George Edward Cosgrave, like his brother, Vivian John, became a policeman. He was sworn in on 24 November, 1911, and was described as being 6 ft. and 1/4 inch tall, with fair hair, fair complexion, brown eyes, and Presbyterian by religion. On 8 July, 1915 he resigned from the New Zealand Police Force, and on 10 August 1915 he joined the Australian Army under the name George Edward Wells (3550). All of the other information in his attestation appears to be correct, so it is not clear why he left a protected job in New Zealand, changed his name, and fought in the Australian Army. On his attestation, George named his sister, Mrs. Annie Jamieson, as his next of kin.

He sailed from Sydney on 5 October 1915 and joined the 11th Reinforcements of the 1st Battalion at Tell El Kebir, Egypt on 6 January 1916. Tell El Kebir was a training centre for the Australian Imperial Force reinforcements, and whilst there, George was promoted to Sergeant on 14 February 1916. He was only in Egypt for two and a half months, before embarking at Alexandria on 22 March 1916, and arrived in Marseilles, France on 28 March.





George's unit was deployed to Flanders in Northern France, and on 29 June 1916, he suffered a shrapnel wound to his right shoulder, requiring his transfer to a rest station at Trois Arbres, near Bailleul, to have it treated. On 7 July he rejoined his unit and 5 days later, on 12 July 1916, George was awarded the Military Medal, a decoration awarded to non-commissioned officers and other ranks, for "acts of gallantry and devotion to duty under fire". The citation reads - "Near Gailly, France on the night of 29/30th June 1916 he saw that the tape was only laid and arranged for a raiding party. He then escorted prisoners through the wire and afterwards, although exhausted, remained behind and assisted to bring in the body of Sergeant Downer and Lieutenant Prior (wounded) on these occasions being under heavy fire".

On 31 July 1916 George was again evacuated to hospital, this time with influenza. He was back with his unit on 21 August, but just over two weeks later, on 6 September, he was again sent to hospital, suffering with varicose veins. He stayed in hospital for almost two months, and was discharged on 29 October, rejoining his unit on 3 November.

Sadly, on 5 November, just two days after rejoining his unit, George was identified as Missing In Action, and on 7 March 1917 was officially declared as Killed In Action. George was buried in a bayonet trench cemetery at Gueudecourt, 2 ¾ miles S.S.W. of Bapaume, Pas de Calais, along with 18 other soldiers of the 1st Australian Infantry Battalion who died the same day. After the war ended, the bodies of the soldiers buried at Gueudecourt were exhumed and reburied at the Grevillers British Cemetery, one mile West of Bapaume. During this transition, the identity of the individual bodies was lost sight of, and so George's exact grave location is not known.

In addition to the Military Medal, George also received, posthumously, the British War Medal, the 1914-1915 Star and the Victory Medal.







Chapter 14 – James Steele Cosgrave (jnr.)



James Steele Cosgrave (junior), the youngest child of James Alexander Cosgrave and Ellen Meale, was born 16 July 1894 at Upper Waiwera, New Zealand.

When World War One broke out, James was working as a bushman in Hawera, but at 20 years of age he travelled south to Palmerston North and on 26 August 1914 he attested for the New Zealand Expeditionary Force, and was assigned regimental number 2/296.

As part of the 1st battery of the 1st brigade, James became a driver with the New Zealand Field Artillery, and on 23 September 1914 he embarked for Egypt, where he served for the next 201 days. Whilst in Egypt, James displayed a somewhat devil may care attitude and was punished for creating disturbances in the mess hall and after lights out, being drunk on duty, insolence to an N.C.O, and for disobeying orders. Perhaps he was just bored, as after he was transferred to Gallipoli on 12 April 1915, he seemed to stay out of trouble. James survived 173 days in Gallipoli, before being transferred back to Egypt, where he was

stationed for another 187 days. His only issue whilst in Egypt was a month and a half spent in hospital due to an abrasion of the knee. He embarked for Europe on 6 April 1916.

After serving six months in Europe, James was appointed acting Bombardier, and on 1 December 1916 was officially promoted to the rank of Bombardier. In early January 1917, he was granted leave in England, and it seems that along the way he picked up a sexually transmitted disease, as he was admitted to the V.D. section of the military hospital at Codford on 9 January 1917.

On 24 March 1917 he returned to his unit in Belgium, rested and with a clean bill of health. But on 2 May he was back in hospital with chicken pox, which kept him out of the action for three weeks. On 24 May 1917 he rejoined his unit in the field and one month later, on 30 June 1917, James was appointed temporary Corporal, when temporary Corporal (2/1002) S.J. Goodyear was promoted to Sergeant. James was promoted to the rank of Corporal on 22 September 1917, when Corporal (2/489) H. Deridder opted to revert to the ranks.

His unit was serving on the Ypres front at the time, and 12 days later, on 4 Oct 1917 Corporal (2/296) James Steele Cosgrave was killed in action, just 11 months after the death of his

brother, George Edward Cosgrave, 100 Km away. He is buried at the Divisional Cemetery, Dickebusch Road, near Leper, Belgium.



Chapter 15 – James Edward Cosgrave and Kathleen Veronica Sherlock



New Zealand had been at war for a little over a year, when Vivian John Cosgrave married Justine Ursula Brady on November 10th 1915. Vivian's brothers, James and George, had signed up for military service and were already serving overseas, so they missed the celebration.

It was a difficult time for New Zealand, having suffered heavy losses in the Gallipoli campaign, so there would have been much joy, when just a few months later, Justine announced that she was pregnant with their first child, a son, who was born in Wellington on January 9th 2017. As their first son, in keeping with the Irish naming tradition, he was named James after his paternal grandfather (James Alexander Cosgrave), and Edward after Vivian's brother, George Edward Cosgrave, who was missing in action in France at that time.

The family of three lived at 228 Tinakori Road, and were soon joined by three more sons and a daughter – George Steele Cosgrave (1919); Noeline Catherine Cosgrave (1920); Vivian John Cosgrave (1923); and Henry Timothy Cosgrave (1924).

In November 1926, Vivian was transferred to Levin, but only 2 years later in January 1929, he was transferred to Hunterville, a sole-charge posting for a senior constable, and the family lived at the police house on Milne Street (State highway 1) in Hunterville.

Nothing is known of James's early education, but he likely attended the local Hunterville school. In 1932, when he was 15 years old, his parents decided to give him the opportunity to attend a better high school than was available in the Hunterville area, and enrolled him as a boarder at St. Patrick's College, Silverstream, in the Hutt Valley. At Silverstream James played rugby in the 7th and 8th

fifteen, so was definitely not a star sportsman. But he did excel at rifle shooting, being considered a first class shot, with a score of 87, just 3 points short of the marksman rating.

His academic prowess may not have been as great as his shooting ability, as he remembered being caned (corporal punishment with a bamboo cane) for getting his homework wrong. It is likely that it was at Silverstream that James also developed his lifelong interest in radio and electronics.

James did not stay at Silverstream beyond one year, opting instead to leave high school and return home to Hunterville, where he worked for a local baker. Here he developed an ability to make excellent scones and other baked goods, learning to adjust the mixture based on the "feel" of the dough. His scone making prowess was much appreciated by his family in later years.

In March 1935, Vivian Cosgrave was promoted to the rank of Police Sergeant, and the family returned to Wellington. James moved back to Wellington with the family and in August 1936 he joined New Zealand Railways as a Guard. Initially, Jim (as he was now known) worked on the Wellington suburban trains, and in June of 1937 he was responsible for organizing the sound system for the opening of the new Wellington Railway Station. He later worked on the main rail lines, being recorded as a Tablet Porter in 1938, in which role he worked on the Wairarapa line and the North Island Main Trunk line.

From Wellington, Jim was transferred to Tokomaru in early 1939, where he stayed at the Guy's boarding house on Rata Street, Tokomaru. Violet Guy, the proprietor's daughter, was something of a matchmaker and introduced Jim to Kathleen (Kath) Sherlock. He and Kath hit it off, but on 3 September 1939 New Zealand declared war on Germany and their lives changed significantly.

On 29 December 1939 Jim attested for the Royal New Zealand Air Force at Weraroa, Levin, and by late January 1940 he was in training as a Wireless Operator at Wigram Air Force Base, near Christchurch.

Jim requested permission from the Air Force, to marry Kath, and on 17 February 1940, that request was approved. Jim purchased an engagement ring, which was mailed to Kath on 14 April, and both families were informed of the planned wedding. In late July, with many of his mates being transferred overseas, Jim was transferred to Ohakea Air Force Base, near Bulls. Perhaps this was a compassionate move, given the planned wedding.

Jim and Kath were married at St. Patrick's Roman Catholic Church in Palmerston North on 3 September 1940. After the wedding, Kath remained living with her mother and sisters, who around this time had moved into Palmerston North and bought a house at 56 Roy Street, and Jim returned to the Air Force.

Jim continued to be stationed at Ohakea, apart from a short stint at Milson in 1942 (where he was promoted to Corporal), until he was transferred to Whenuapai, near Auckland in September 1943. After only a few days at Whenuapai, he was transferred to Waipapakauri and then on to Ardmore. While Jim was stationed at Ardmore, he was promoted to Sergeant, and Kath gave birth to their first child, Margaret Ann Cosgrave. Jim was not home for the birth, but did get leave soon after, to see his baby daughter.

On 26 October 1944 Jim was transferred to Lauthala (Laucala) Bay on the island of Viti Levu in Fiji. New Zealand had been

given responsibility for air reconnaissance around Fiji, and this was to be done with flying boats. The base at Lauthala Bay was developed to house the Catalina and Sunderland flying boats which fulfilled this mandate. Jim told stories of the flying boats landing two-man teams at remote islands, to spend weeks at a time, observing the sea in the area, looking for enemy ships and submarines. The radio operator was crucial to this work, as radio was the only means of communications with base. He claimed that the crews lived primarily on whiskey and bananas, to augment the military rations provided.

Soon after V.E. Day (8 May 1945) Jim was hospitalised for a short period with Dengue Fever, from which he recovered well.

The war officially ended with the surrender of Japan on 15 August 1945, but No. 6 Flying Boat Squadron was to stay in Fiji until their work could be transitioned to the civil aviation authority. Flight Sergeant (391966) James Edward Cosgrave returned to New Zealand in December 1945, after an 8 ½ hour flight on a Catalina from Fiji. He was officially discharged from the Air Force on 8 February 1946, and was entitled to wear the 1939-45 Star, the Pacific Star, the Defence Medal, the War Medal, and the N.Z. War Service Medal.

In 1946 Jim and Kath bought a house at 18 Haydon Street, Palmerston North, which remained their home until their deaths. The house was built largely with recycled materials as access to new building material was still restricted due to the war. In 1958-59, the wash-house (complete with wood-fired water heater) was removed and a small addition was made to the rear of the house. At that time, the recycled roofing iron was also replaced.

Jim and Kath Cosgrave had 4 children in total, as listed below, but the second born lived only a few hours –

- Margaret Ann Cosgrave
- Vivienne Mary Cosgrave, born 5 June 1947; died 6 June 1947
- Patricia Ursula Cosgrave
- James John Cosgrave (the author)

After the war Jim hoped to open a neighbourhood convenience store (a dairy in New Zealand parlance), but it seemed that the local co-operative society was granted all of the permissions to build, with individuals left out in the cold. At a public meeting on the topic, Jim stated that he would walk bare-footed over broken glass to Awapuni (the other side of town) and carry his groceries home in a sack before setting foot in a co-op store, a pledge that he stuck to throughout his life.

Jim worked at Coles, a music and electrical shop on The Square in P.N., until the mid-1950s when he set up his own business, Communications Services, in the rapidly expanding field of mobile radio communications. Jim did the technical work, and Kath handled the office side of the business.

Running his own business as a one-man show, Jim did not take long holidays, but managed the occasional long weekend trout fishing with friends and relatives. Jim was on good terms with Monsignor Cullen, who had a rustic cottage on the southern shores of Lake Taupo at Pukawa.

Family holidays were spent at Monsignor Cullen's cottage, and involved Jim driving the family to Pukawa on a Friday night, staying the weekend to ensure that all was working well (generator for electricity, water pump, etc.), do a little fly fishing in the evening, and then driving home for the work week. He would return the following weekend to pick the family up. At least once during the week, Kath would make the trek up the dirt track to the road (often with one of the younger children in tow), hitchhike into Tokaanu, buy essential groceries and hitchhike back to Pukawa.

The British company, Pye Telecommunications Ltd., had begun selling their radio-telephones (two-way radios in North American parlance) in New Zealand in 1951, and these products became popular for mobile communications by emergency services and other fleet operators that needed to be in instant touch with their field staff. Communication Services became a regional dealer of Pye Electronics in New Zealand, a relationship which endured until the business was wound up after Jim's death.

At that time, telephone, telegraph and radio communication systems in New Zealand were primarily provided by the Post Office and it was illegal to compete with the Post Office for telecommunications revenues. However, technology was moving forward faster than the Post Office's ability to deliver service, and organizations were permitted to provide radio communications facilities for their own use where no Post Office service existed.

Communication Services became a leader in providing these systems to regional Power Boards (electricity distributors), and Catchment Boards (water resource and control organizations), municipalities, vets, taxis, etc.


As mobile communication system use spread to trucking and other industries, the Post Office could not keep up with the demand for service, and they began licensing User Associations (groups of organizations that required radio services in a geographical area) to provide services for their members.




Communication Services new workshop (abt. 1960).

Communication Services was heavily involved in the engineering and maintenance of such systems throughout the Wairarapa and Hawkes Bay.

In the mid-1980s, Jim was diagnosed with leukemia, a diagnosis that was in common with several others involved with early radar systems during the war, suggesting that there may be a link between their wartime activities and their health. Around this same time, cellular mobile telephone service was introduced in New Zealand (1987), and this service rapidly overtook the traditional mobile communications services. Jim worked with mobile communications equipment from its war time beginnings, through its heyday, and the beginning of its decline, before passing away at the Palmerston North Public Hospital on 30 June 1988 at 71 years of age. Kathleen lived on for ten more years, and died peacefully at home on 23 April 1998 at the age of 82 years. Both are buried in the Kelvin Grove Cemetery in Palmerston North.



Chapter 16 – George Steele Cosgrave



The second child of Vivian and Justine Cosgrave was George Steele Cosgrave, who was born 24 March 1919. He attended Hunterville School, Marton District High School (1933-1934) and St. Patrick's College, Wellington (1935-1936). After leaving high school, George joined the civil service, working in the Industries and Commerce Department.

The Second World War put his career on hold, as on 29 October 1940, at the age of 21, George joined the Royal New Zealand Air Force, as a Leading Aircraftman (Airman Pilot). He underwent basic training at Harewood, was remustered as an Air Observer in Levin, and at the end of February 1941 he sailed out of Auckland on the ship *Awatea* bound for Canada, where he underwent training as an Air Observer. The training was provided by the Royal Canadian Air Force as part of the British Commonwealth Air Training Plan.

In Canada George was stationed in Prince Albert, Saskatchewan (Air Observer School), MacDonald, Manitoba (Bombing and Gunnery School), Rivers, Manitoba (Central Navigation School), Debert, Nova Scotia (31 O.T.U.). In September 1941 he was posted to the U.K., where he worked as an instructor for the following year and a half, apart from several short postings to operations units in India and Egypt. He was promoted to Flight Sergeant on 1 June 1942, gained a temporary commission as a Pilot Officer on 12 September 1942, and was promoted to Flying Officer in March 1943.

In a letter home in December 1943 George bemoaned the fact that without more operations time he could not be promoted above the rank of Flight Lieutenant, so was hoping for a posting to an operations unit.

In February 1944 George was posted to India for ten months, where he was attached to 355 Squadron, and was promoted to Flight Lieutenant in September 1944.

On 3 January 1945 George was repatriated to New Zealand, having spent 3 years and 310 days overseas. He then served with 40 Squadron, flying throughout the Pacific. On his return to New Zealand after a flight in April 1945 George was charged with breaching Air Force regulations for bringing in 3 ½ cartons of cigarettes. This was not against Customs regulations and he had declared the cigarettes and paid the duty, but it seems he was caught up in a report by Customs of goods secreted within the aircraft and would not normally have been charged as Customs did not enforce Air Force regulations. He received his one and only reprimand for this offense.

On 19 February 1946, Flight Lieutenant (403952) George Steele Cosgrave was discharged from active service to the Reserve A List. His commission was officially terminated on 1 June 1956. During his service, George had flown a total of 826 hours on Anson, Battle, Hudson, Wellington and Liberator aircraft.

For his wartime service, he earned the Burma Star, Defence Medal, African Star and Pacific Star.

After leaving the Air Force, George rejoined the Industries and Commerce Department of the New Zealand government on 1 April 1948, as a Clerk in Wellington. He was later posted to Melbourne and by 1950 he was the Assistant Trade Commissioner in Bombay, India. George remained in India, serving as acting Trade Commissioner for an extended period in 1952, before returning to New Zealand in early 1953.


George became estranged from the rest of the family around 1957, and died in Auckland Hospital on 23 July 1987 at 68 years of age. He is buried in the family plot at the Foxton Cemetery, with his parents and sister Noeline.

Chapter 17 - DNA Testing

The foregoing chapters have identified a strong paper trail back to Thomas Cosgrave, born circa 1769 (place unknown), and a high likelihood that Thomas was a son of Alexander Cosgrave and a grandson of Daniel Cosgrave, but we don't have any knowledge of the Cosgrave family before the early 1700s. It is hoped that DNA testing might help to break down this brick wall.

Autosomal DNA testing, through companies such as Ancestry, 23andMe, My Heritage and FamilyTreeDNA, is of huge benefit to genealogists in confirming connections identified by researching the paper trail of our ancestors. If two people who have well-researched family trees, which identify a common ancestor, also share autosomal DNA, and if there is no other obvious ancestral connection, then it is highly likely that the identified common ancestor is correct. I have found several Cosgrave cousins, some previously unknown to me, through autosomal DNA testing, including descendants of four of the five children of James Steele Cosgrave and Anna O'Neill who had children (3rd cousin level). I have also made contact with two 4th cousins (descendant of siblings of James Steele Cosgrave, through DNA testing, which is likely close to the limit for finding connection through autosomal testing.


The chart below shows several of my Cosgrave connections confirmed with autosomal DNA testing, but all known connections have not necessarily been included in the chart to improve readability.

In addition to my own DNA test result, I have access to view the DNA matches of Jill, shown in the chart above as a descendant of Alfred E. Cosgrave (1854-1927). In early 2024, I identified Chris as an Ancestry DNA match to Jill, and their shared DNA matches include three other known descendants of James Steele Cosgrave (1820-1894). Chris was born in Ontario, Canada and his online tree shows that he has Cosgrave ancestry. His Cosgrave line immigrated to Canada from Manchester, Lancashire, and earlier generations were from County Antrim, Ireland. Chris' earliest documented ancestor is Alexander Cosgrave (b. 1793 in Co. Antrim), whose 1840 marriage registration (his second marriage) states that his father was

Daniel Cosgrave, a builder. The given names Daniel and Alexander feature prominently in my Cosgrave ancestry, increasing the likelihood of Chris and I sharing a common ancestor. I therefore explored how Chris' Cosgraves might connect to my Cosgrave family. The Irish naming tradition was to name the first-born son after the father's father and the second son after the mother's father. Thomas Cosgrave and Margaret Steele had two sons and they followed the naming tradition, naming the eldest son Alexander after Thomas' father, and naming the second son James Steele after Margaret's father. Based on birth years and if the naming tradition was followed in earlier generations, I have tentatively identified the connection to Chris as shown in the chart below, with Daniel Cosgrave being an older brother of Thomas Cosgrave (1769-1854) –

Chris and Jill share DNA with Trevor, Chelsea and Johanna shown inside the red oval in the chart above. We will likely never find records that shown definitively the connection between Chris' Cosgrave line and mine, but we know that we do share a common ancestor. Hopefully at some point Chris will take a Y-DNA test which might help to confirm the connection.

There are many other people who have taken DNA tests, with whom I share significant amounts of autosomal DNA, and with whom I may share a common Cosgrave ancestor, but there is no paper trail to establish the correct relationship.

For more distant connections on the male ancestral line, Y-DNA testing can also be very useful, so I took a 67-marker Y-DNA test through FamilyTreeDNA. The Y-chromosome is passed down the male line from father to son, largely unchanged, although mutations do occur from time to time. It is these mutations that create what is termed "genetic distance" between Y-DNA samples – the genetic distance between two samples increases by 1 with each mutation on either line of descent from a common ancestor. The relative stability of the Y-chromosome is therefore useful in identifying common male ancestors in ancient times.

My test result identified my high-level Y-haplogroup as R-DF21which is extremely common in Scotland and Ireland, and FamilyTreeDNA identified 5 other men as being close Y-DNA matches to me, but none had the surname Cosgrave. The individuals identified as my closest Y-DNA matches have the surnames McConnell, Stewart, Teuwen, Moerker and Jansen.

Assuming that none of my paternal line grandmothers was playing away from home (what the DNA industry calls a non-paternal event or NPE), my Y-DNA should be largely shared with other males who have the Cosgrave surname, back to the point in history where surnames were first adopted. This does not mean that I will closely match all Cosgrave males, as not all Cosgrave males are necessarily descended from the same individual. But I was somewhat disappointed to not match anybody with the Cosgrave surname or some variant of it, such as Cosgrove, Cosgriff, etc.

I joined the Cosgrove DNA project on FamilyTreeDNA, upgraded my 67-marker test to a 111-marker test and later to the Big-Y 700 test, which is the most detailed Y-DNA test currently available. The Big-Y test narrowed down my paternal haplogroup to R-FGC9749, which was 4 branches below R-DF21. I say "was" as the tree is being expanded all the time, with new branches being added.

The Cosgrove DNA project includes all variants of the Cosgrove surname, and to date, the project has identified eight separate genetic groupings among the male participants who have taken Y-DNA tests, which include the surnames Cosgrave, Cosgrove, Cosgriff, McOsker, McCusker and Coskery.


In May of 2019, Patrick Cosgrove took a 37-marker Y-DNA test, and became my closest Y-DNA match to date. Patrick later upgraded to the Big-Y 700 test, resulting in FamilyTreeDNA assigning us our own haplogroup, R-FT212122, a sub-clade of R-FGC9749. Patrick shares 19 of my 25 previously un-named variants, and has two unique variants of his own. This suggests that my line has had six (25 minus 19) mutations since our common ancestor, and Patrick's line has had only two. Patrick's earliest known ancestor is a Thomas Cosgrove, who was likely born in Dundonald, County Down in about 1812. Dundonald is only about 10 miles from Malone.

We were soon joined in our R-FT212122 haplogroup by David McConnell whose ancestry is from the Isle of Man, and this resulted in Patrick and myself being assigned a new sub-clade (R-FT212599), as our line and David's line diverged several hundred years earlier – i.e. Patrick and I share some mutations that David does not have.

Despite the geographical proximity of Malone and Dundonald, and the similarity of our surnames, after much effort from Patrick's cousin Isabel Cosgrave and myself, we have not

been able to determine who our common ancestor may have been, but we feel that we are close.

I hope that as more men take Y-DNA tests in the future, we will be able to narrow down our connection further, to better understand the migration of our Cosgrave / Cosgrove ancestors, prior to their arrival in Upper Malone.



We know that our male Cosgrave ancestors came out of Africa more than 100,000 years ago and when the ice age ended about 11,500 years ago, they migrated through the Iranian Plateau and into Eurasia. Around 5,000 years ago they spread through Europe to the Atlantic coast, and their Y-DNA continued to mutate through the Bronze Age (R-L21) and the Iron Age (R-DF13), before becoming R-DF21 about 2,000 years ago, speaking Gaelic and being early Christians.

The bottom line is that we have a gap in our Cosgrave history between 2,000 years ago and 400 years ago, which would be nice to understand more clearly.
